KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 27th day of March, 2006, Autum K. Evans and Noah D. Evans, wife and husband, executed that certain mortgage on real property hereinafter described to Mortgage Professionals, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20060330000148830, said mortgage having subsequently been transferred and assigned to Trustmark National Bank, by instrument recorded in Inst. # 20060330000148840, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, on April 8, 2008, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and Trustmark National Bank did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and


