

## PARTIAL RELEASE

It is understood and agreed that the said SOUTHTRUST BANK NKA WACHOVIA BANK hereby declare the above described mortgage to be DISCHARGED, RELEASED and SATISFIED with respect to the property described herein only; said mortgage shall in all other respects remain in full force and effect as a lien against all of the remaining property described therein.
