KNOW ALL MEN BY THESE PRESENTS, That in consideration of other good and valuable considerations and the sum of **One Hundred Sixty Two Thousand and 00/100 Dollars (\$162,000.00)** to the undersigned GRANTORS in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, **William J. Knapp and Karen R. Knapp, husband and wife** (hereinafter referred to as GRANTORS), do hereby grant, bargain, sell and convey unto **Ronald C. Reed and wife, Rebecca C. Reed** (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in the County of **Shelby** and State of Alabama, to-wit:

Lots 3 and 3-A, according to the Survey of Dearing Downs, 12th Addition, 1st Phase, as recorded in Map Book 16 page 18 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.
