**MORTGAGE FORECLOSURE DEED**

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, heretofore on, June 25, 2007, to wit, Paul Hodges and Sabrina Alexander, husband and wife, executed and delivered to Regions Bank d/b/a Regions Mortgage, a mortgage conveying to Regions Bank d/b/a Regions Mortgage, the property hereinafter described, which said mortgage was given to secure an indebtedness therein mentioned, and which mortgage is recorded in the Office of the Judge of Probate of Shelby County, Alabama, under Instrument Number 20070706000319840; and
