- 1. ARTICLE XI of the Original Declaration is hereby amended to add the following as "(J)" thereof.
 - (J) The Owner shall construct a structure on each lot and the construction of such structure requires that certain eaves, roof overhangs, brick veneers, siding and/or other

architectural features and building materials encroach upon or have over continuous lots. Accordingly, there is hereby created, granted and reserved as an appurtenance to each lot a perpetual easement over and across each lot. In addition, there is hereby created, granted and reserved to the owner or owners of each lot a license and right of entry across contiguous lots as may be reasonable needed to maintain and repair such encroachment or overhanging structures. If any house shall be damaged or destroyed, the owner or owners thereof shall be permitted to repair and reconstruct such house with encroachments or overhangs not more intrusive than those existing at the time of such damage or destruction and thereafter said license and right of entry shall continue in effect.

The Association has joined in the execution of this Supplemental Declaration for the purpose of evidencing its written approval of the addition of Section (J) to the Original Declaration as herein provided and does hereby authorize the filing of this Supplemental Declaration with the Office of the Judge of Probate of Shelby County, Alabama.
