MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on July 2, 2004, **Bruce L. McCormick, an unmarried man, Party of the First Part**, executed a certain mortgage to **Ameriquist Mortgage Company**, which said mortgage is recorded in Instrument No. 20040716000394820, in the Office of the Judge of Probate of Shelby County, Alabama Which said Mortgage was last sold, assigned and transferred to Deutsche Bank National Trust Company, as Trustee, in trust for the registered holders of Ameriquist Mortgage Securities Inc., Asset-Backed Pass-Through Certificates, Series 2004-R9; and
