

ARTICLES OF INCORPORATION

OF

CHICKEN SCRATCH AT 280, INC.


1. The name of the corporation is Chicken Scratch at 280, Inc.
2. The period of its duration is perpetual.
3. The purpose or purposes for which the corporation is organized are **to own quick, casual dining restaurants**; and to engage in any lawful act or activity for which a corporation may be organized under the Alabama Business Corporations Act.
4. The aggregate number of shares of capital stock which the corporation shall have the authority to issue is **1000** shares of common stock, par value of **\$1.00** per share.
5. The location and mailing address of the initial registered office of the corporation is **1904 Indian Lake Drive, Birmingham, Alabama 35244** and the name of its initial registered agent at this address is **Courtney H. Mason, Jr.**
6. The number of directors constituting the initial board of directors of the corporation is 2, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders and until their successors are elected and shall qualify are as follows:


8. Each shareholder shall have a pre-emptive right to purchase shares of any class of capital stock of the corporation, including treasury shares.

Purchases by the corporation of its own shares, whether direct or indirect, may be made to the extent of unre-served and unrestricted earned surplus and capital surplus of the corporation available therefor.
