FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 26th day of November, 2003, Cynthia A. Lee, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Countrywide Home Loans, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20031201000777540, said mortgage having subsequently been transferred and assigned to Bank of New York as Trustee for the Certificate Holders of CWALT 2004-J4, by instrument recorded in Instrument Number 20071008000468490, in the aforesaid Probate Office ("Transferee"); and

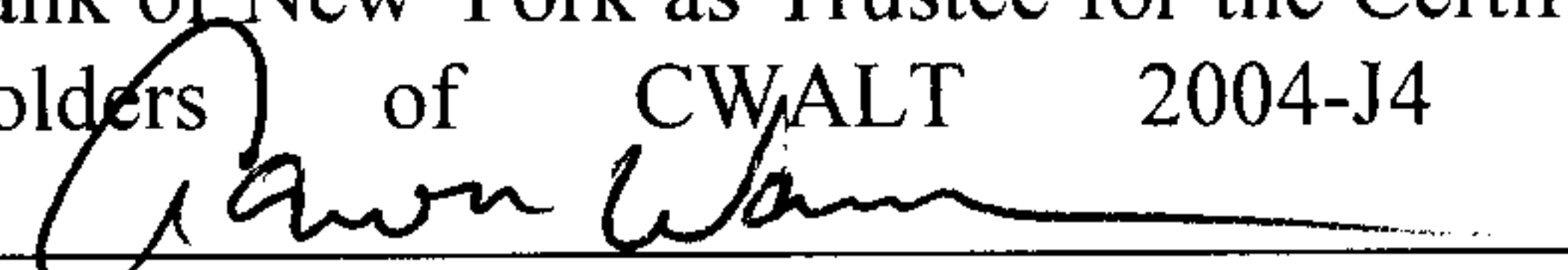
