

## LOAN MODIFICATION AGREEMENT

This agreement is by and between Regions Bank ("Bank") and Commonwealth Development Group, LLC. ("Borrower"). WHEREAS, Borrower is indebted to Bank on a ("Loan"), as evidenced by a Promissory Note and Mortgage, dated February 28, 2003, said mortgage recorded in Mortgage Book 20030304000130860 in the Probate Office of Shelby County, Alabama. WHEREAS, Borrower and Bank desire to modify the terms of said loan as set forth here. NOW THEREFORE, for and in consideration of the premises, Borrower and Bank agree that the terms of the Loan are modified as follows:

a. The original loan commitment of \$35,000.00 (current balance is \$16,335.22) shall be increased to \$75,000.00 representing new money in the amount of \$58,664.78. This additional \$58,664.78 shall be disbursed by the "Bank" as additional funds are required by the "Borrower". If all funds are not required, the balance shall be applied to the note referenced herein. All other terms, conditions and collateral of the note herein referenced shall be made a part of this modification agreement and control the repayment terms thereof.

Except as modified herein, all of the terms and conditions of the Loan, the Note and Mortgage and any and all other instruments executed in connection with said Loan shall remain in full force and effect.


