THIS FORECLOSURE DEED made this 6th day of May, 2008, between LARRY MORGAN and DONNA S. MORGAN, husband and wife, Parties of the First Part, and GREEN TREE – AL LLC F/K/A CONSECO FINANCE CORP. - ALABAMA, Party of the Second Part;

W I T N E S S E T H:

WHEREAS, the said LARRY MORGAN and DONNA S. MORGAN, husband and wife, heretofore executed to CONSECO BANK, INC., herein called the Mortgagee, a certain mortgage dated June 26, 2000, and recorded in Instrument No. 2000-23097, Probate Records of Shelby County, Alabama, which conveyed the hereinafter described property to secure the indebtedness evidenced by a note, payable in installments, therein described; and

WHEREAS, parts of said indebtedness remained unpaid at the respective maturities thereof, and the whole of said indebtedness thereupon became due and payable, and default was made in payment thereof, and the Party of the Second Part thereafter gave notice by publication in The Shelby County Reporter, a newspaper of general circulation and published in Shelby
