VERIFIED STATEMENT OF LIEN

Builders FirstSource – Southeast Group, LLC, successor in interest to certain assets of Saturna, Inc., d/b/a Wheeler’s Building Supply (“Builders FirstSource”), including, but not limited to, the debt made the subject of this lien, whose address is 315 Highway 433, Chelsea, Alabama 35043, files this statement in writing, verified by the oath of Millard Martin, Credit Manager of Builders FirstSource, who has personal knowledge of the following facts:

Builders FirstSource claims a lien on property situated in Shelby County, Alabama, which is more particularly described as follows:

Lot 22-94, according to the Survey of Highland Lakes, 22nd Sector, Phase II, an Eddleman Community, as recorded in Map Book 36, Page 94 A-C, in the Probate Office of Shelby County, Alabama (“the Property”)


This lien is claimed, separately and severally, as to both the land and the buildings and improvements situated thereon to the extent of the entire lot or parcel which is contained within a city or town. If said land is not contained within a city or town, then this lien is claimed, separately and severally, as to the buildings and improvements situated on the Property, plus one (1) acre of land surrounding and contiguous therewith.

This lien is claimed to secure a due and unpaid indebtedness of \$1,324.93, plus interest, attorney’s fees, and costs, from December 28, 2007, owed to Builders FirstSource by Jim Whatley Construction Company, Inc., for lumber, doors and other building and construction-related materials (“materials”) furnished from on or about October 5, 2007, through on or about December 28, 2007, in connection with the construction of improvements situated on the Property. The materials were


