Know all men by these presents, that for and in consideration of **Three Hundred Forty Five Thousand and No/100 dollars (\$345,000.00)** and other good and valuable consideration in hand paid to **Compass Bank**, an Alabama banking corporation (hereinafter referred to as "Grantor") by **Robert J. Kemp and Kimberly A. Kemp**, (hereinafter referred to as "Grantees") the receipt and sufficiency of which are acknowledged hereby, Grantor does by these presents grant, bargain, sell and convey unto the said Grantee, for and during their joint lives and upon the death of either, then to survivor of them in fee simple, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, the following described real estate situated in Shelby County, Alabama (the "Property"),

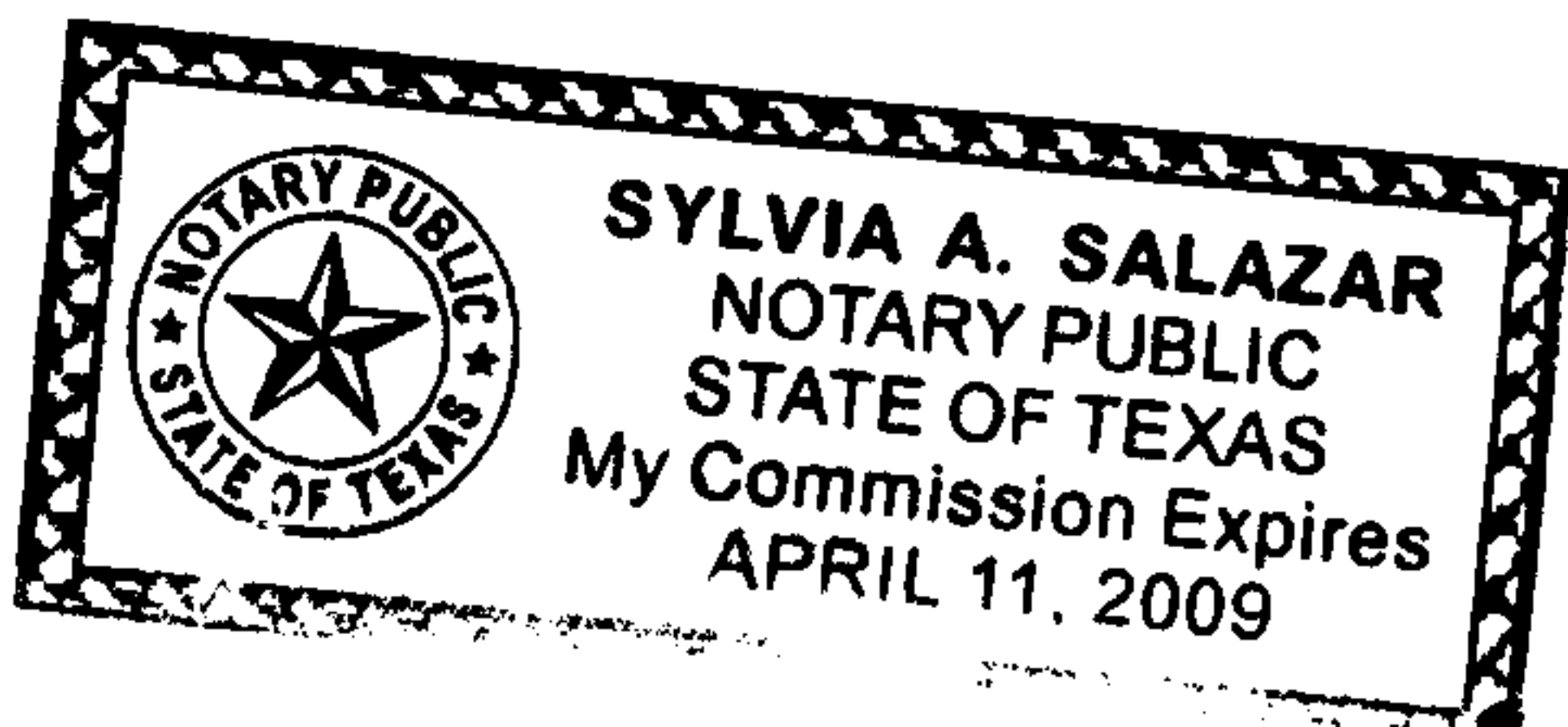
