

PARCEL I: E ½ of SE 1/4; all that part of E ½ of W ½ of SE 1/4 and all that part of NW 1/4 of NW 1/4 of SE 1/4 lying South of center line of Highway 43, also known as Bear Creek Road; said land being located in Section 1, Township 19 South, Range 1 West; Shelby County, Alabama.
