FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 1st day of May, 2003, Mildred E. Mills and son Edward Lewis Mills , executed that certain mortgage on real property hereinafter described to Washington Mutual Finance LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20030505000274630, said mortgage having subsequently been transferred and assigned to Citifinancial, Inc., ("Transferee"); and

WHEREAS, on June 3, 2008, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and Citifinancial, Inc. did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, Michael Corvin as member of Corvin Auctioneering, LLC was the auctioneer who conducted said foreclosure sale and was the person conducting the sale for the said Citifinancial, Inc. ; and
