### Subordination Agreement

THIS AGREEMENT is made and entered into on this **8** day of **January 2008**, by Regions Bank (hereinafter referred to as "Regions") in favor of **WELLS FARGO BANK, NA**, its successors and assigns (hereinafter referred to as "Lender").

*By its acceptance of this agreement, the Borrower agrees to pay the Subordination Fee set out in the Regions Subordination Request Form.*

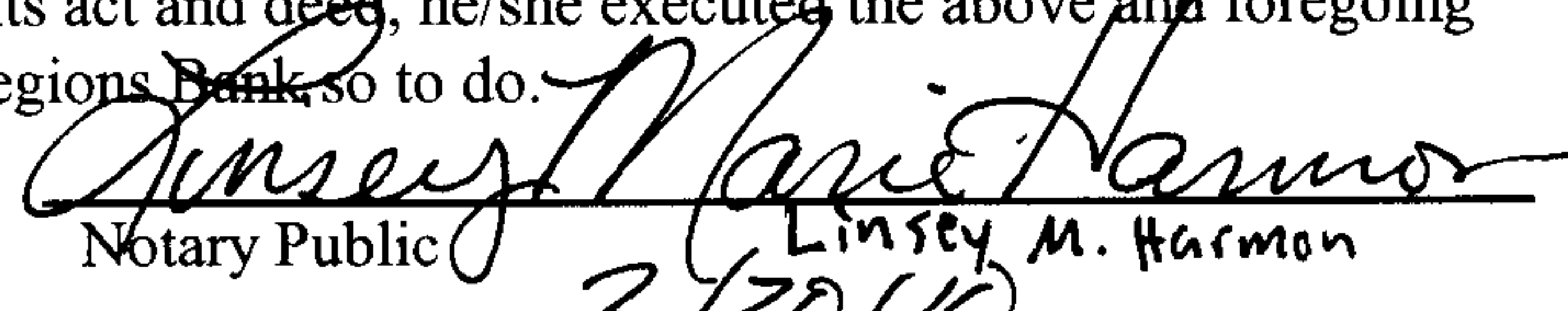

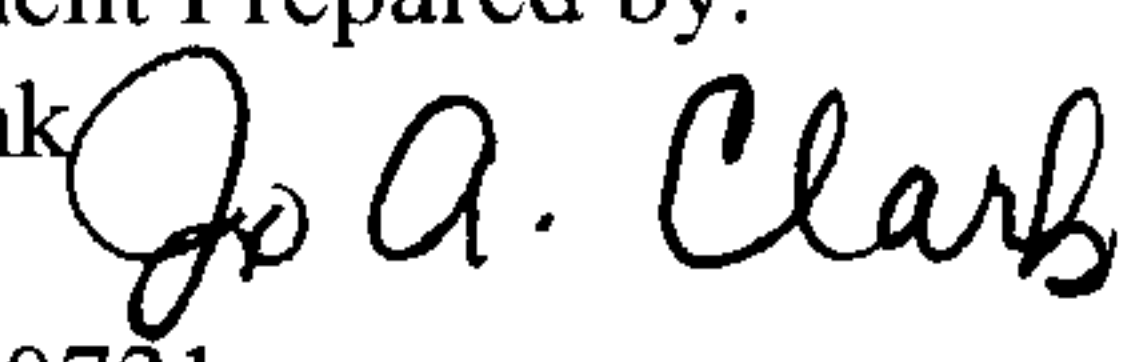

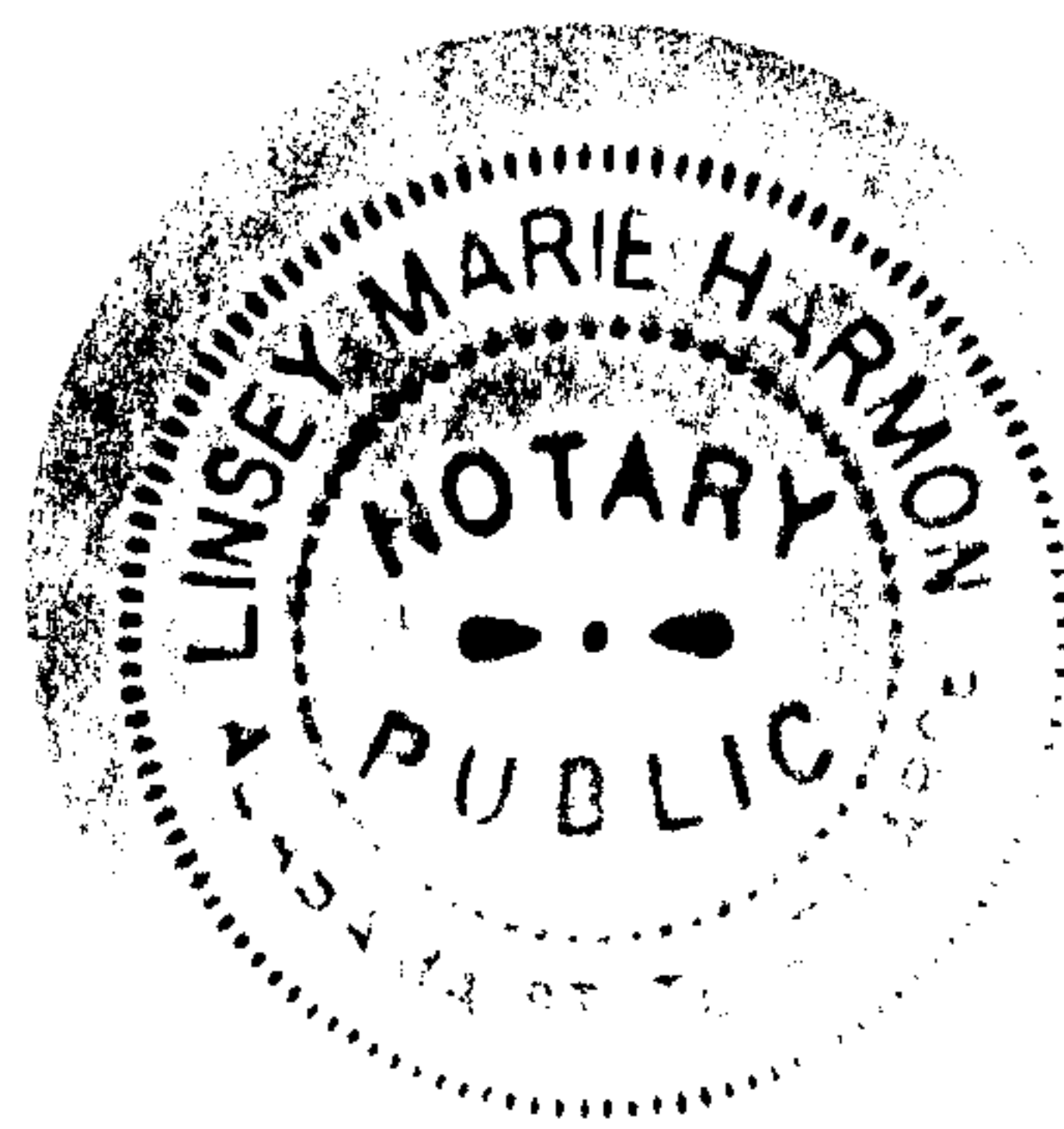
