Know All Men by These Presents: That in consideration of **One hundred thirty four thousand five hundred and no/100 (\$134,500.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Shannon M. Coker and George D. Coker, III, wife and husband** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Derek F. Ellis and Cecelia M. Ellis** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:
