**Article I**

The name of this corporation shall be, Dynamic Growth and Success for Churches Individuals and Groups Incorporated.

**Article II**

Duration of Dynamic Growth and Success for Churches, Individuals and Groups Incorporated shall be perpetual unless dissolved.

**Article III**

Dynamic Growth and Success for Churches, Individuals and Groups Incorporated, is organized exclusively for charitable, religious and educational purposes, including, but not limited to; providing orthodox Protestant Christian evangelical churches, low income persons, poor, distressed, and needy individuals, community groups, and business organizations with resources, training, education and strategic planning for positive community building growth , the making of distributions to organizations that qualify as exempt under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

**Article VIII**

No part of the net earnings of Dynamic Growth and Success for Churches, Individuals and Groups Incorporated shall inure to the benefit of or be distributable to its members trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purpose set forth in Article (3) thereof. No substantial part of the activities of Dynamic Growth and Success for Churches, Individuals and Groups shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, Dynamic Growth and Success for Churches, Individuals and Groups Inc. shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue code or the corresponding section of any future federal tax code or by corporation contributions which are tax deductible under section 170 (c)(2) of the Internal Revenue code.

**Article IX**

This corporation pursuant to the Tax Payer Bill of Rights( 2) will make available for public inspection approved application for recognition of exempt status along with required annual reports and will make copies upon request without charge (other than what is reasonable for reproduction and copying).

**Article X**

Upon dissolution of Dynamic Growth and Success for Churches Individual and Groups Inc., assets shall be distributed for one or more exempt purposes within the meaning of 501(c)(3) of the Internal Revenue code or the corresponding section of any future federal code or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located .Exclusively for such purposes or to such organizations, as said court shall determine, which are organized exclusively for such purposes

**Article XI - Special Provision:**

Dynamic Growth and Success for Churches Individuals and Groups Incorporated would desire and designate all assets, upon dissolution, to be granted to Southeastern Bible College in accordance with the legal code in pursuant to Internal Revenue code to dissolution of 501(c) (3) requirements.



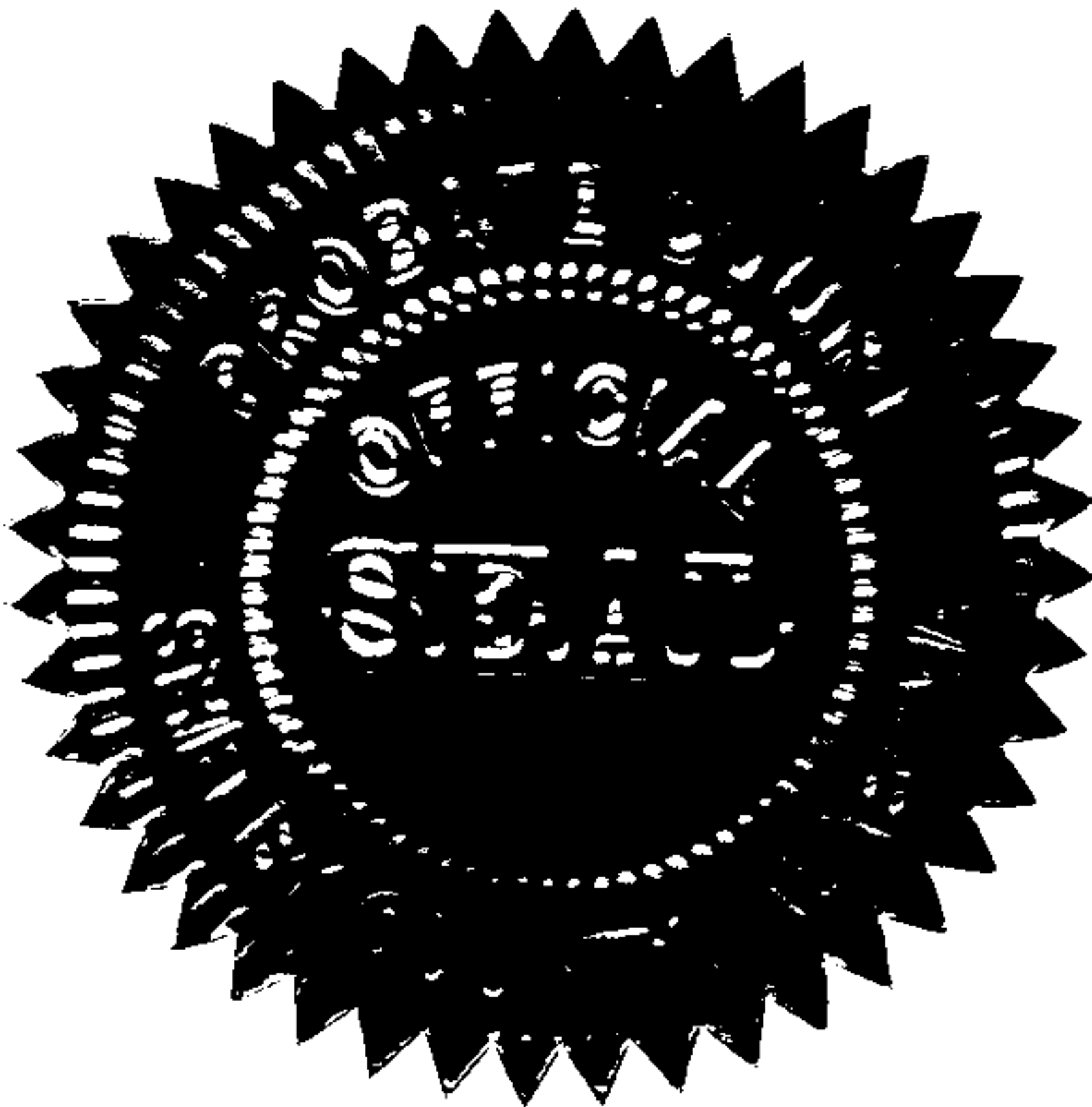


