AFFIDAVIT

Before me, the undersigned Notary Public, in and for the State of Alabama, personally appeared Timothy D. Jacobs, who, having been by me first duly sworn, deposed as follows:

1. My name is Timothy D. Jacobs. I am over the age of twenty-one (21) years, and have personal knowledge of the facts stated herein.
2. On January 3, 2008, I executed a deed to Randal and Cassie Jones, conveying the following described property:

A parcel of land lying in the SE 1/4 of the SE 1/4 of Section 19, Township 20 South, Range 2 East, and more particularly described as follows: Starting at the Southwest corner of the said SE 1/4 of SE 1/4, Section 19, Township 20 South, Range 2 East, run Northerly along the West boundary line of the said SE 1/4 of SE 1/4 a distance of 45.0 feet to an iron marker on the North right of way line of an easement for a road and utilities, the point of beginning; thence continue Northerly along the said West boundary of the said SE 1/4 of SE 1/4 a distance of 326.5 feet to an iron marker; thence turn an angle of 90 deg. 00 min. to the right and run Easterly a distance of 851.2 feet to an iron marker on the West right of way line of Shelby County Highway No. 441 (Yellowleaf-Robinson Public Road); thence run Southwesterly along the said West right of way line of said Highway No. 441 a distance of 353.5 feet to an iron marker on the said North right of way line of said easement for a road and utilities; thence run Westerly along the said North line of said road and utilities easement, a distance of 715.9 feet to the point of beginning; being situated in the SE 1/4 of the SE 1/4, Section 19, Township 20 South, Range 2 East, Shelby County, Alabama. Less and except property described in Instrument #1992-8264; being situated in Shelby County, Alabama.

This deed is recorded in Instrument 20080103000002820 in the Probate Office of Shelby County, Alabama. Said deed does not contain the marital status of Timothy D. Jacobs.

4. At the time of the execution of the above mentioned deed, Timothy D. Jacobs was a unmarried individual.
5. Subject property did not constitute the homestead of Timothy D. Jacobs or his spouse at the time of the execution of the deed, as defined by the Code of Alabama.
