EXHIBIT "A" - LEGAL DESCRIPTION

A parcel of land located in the Southwest 1/4 of the Northeast 1/4 of Section 14, Township 20 South, Range 3 West, Shelby County, Alabama, more particularly described as follows: Commence at the Northwest corner of said 1/4-1/4 section; thence in an Easterly direction along the north line of said 1/4-1/4 section a distance of 244.0 feet; thence 93° 13' 38" right, in a southerly direction a distance of 132.81 feet to the point of beginning; thence continue along last described course a distance of 438.33 feet; thence 89° 29' left to tangent of a curve to the right, said curve having a radius of 2063.57 feet and a central angle of 4° 41'; thence along arc of said curve in a southeasterly direction a distance of 168.68 feet to end of said curve; thence continue in a southeasterly direction a distance of 104.80 feet to the beginning of a curve to the left, said curve having a radius of 2177.77 feet and a central angle of 0° 35'; thence along arc of said curve a distance of 22.5 feet to the southwest corner of South Central Bell Telephone Company lot; thence 95° 47' 32" left, measured from tangent of said curve; in a Northerly direction along the West line of said Telephone Company lot a distance of 450.0 feet; thence 88° 24' 09" left, in a northwesterly direction a distance of 295.0 feet to the point of beginning.
