Know All Men by These Presents: That in consideration of **One hundred sixty three** thousand and no/100 (\$163,000.00) to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Ryan C. Splittgerber and Brienne Splittgerber, husband and wife** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Angel R. Stewart and Jeffrey Stewart** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby** County, Alabama, to-wit:

Lot 32, according tot he Survey of Silver Creek, Sector II, Phase I, as recorded in Map Book 29, Page 81, in the Probate Office of Shelby County, Alabama.
