I.

I hereby revoke all wills and codicils heretofore made by me if there be any.

II.

I hereby direct that all of my just debts be paid out of my estate without unreasonable delay.

III.

I give, devise and bequeath all of my property and interests in property, where-soever situated, that I may own or have the power of testamentary disposition over at my death, to my beloved wife, Janice M. Dobbins, in fee simple and absolutely.

IV.

I intentionally omit to make provision herein for my child, Durall Parker Dobbins, Jr., except as provided hereinafter.

V.

If my said wife should predecease me, or if we should both die as a result of a common disaster, illness, or other calamity, and there is no sufficient evidence that we have died otherwise than simultaneously, then and in either event I give, devise and bequeath all of my property to my said child, living at my death.

VI.

I hereby nominate and appoint my said wife to be Executrix of this, my Last Will and Testament, and direct that she shall not be required to give any bond or other security for the faithful performance of the duties of the office.
