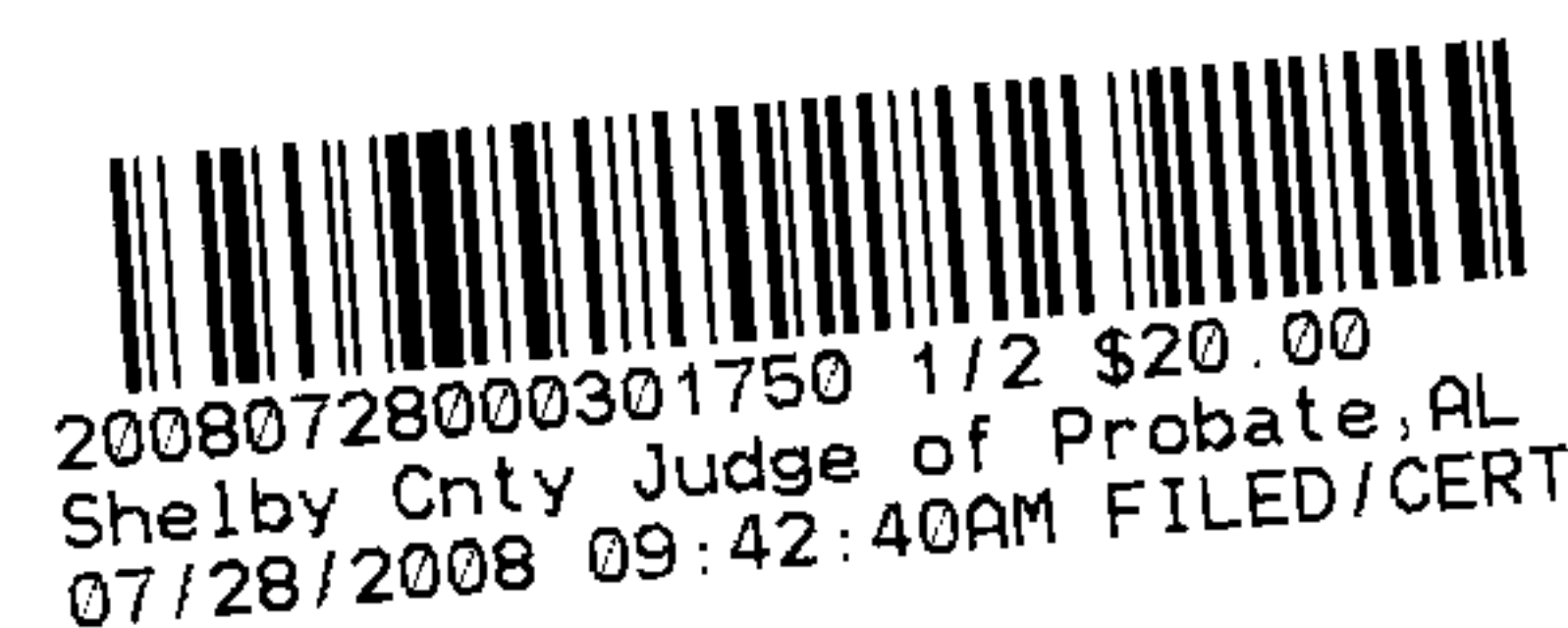

AUCTIONEER'S DEED

WHEREAS, MARTIN RYAN YEAGER and ALYSON G. YEAGER, Husband and Wife executed a mortgage to Mortgage Electronic Registration Systems, Inc. 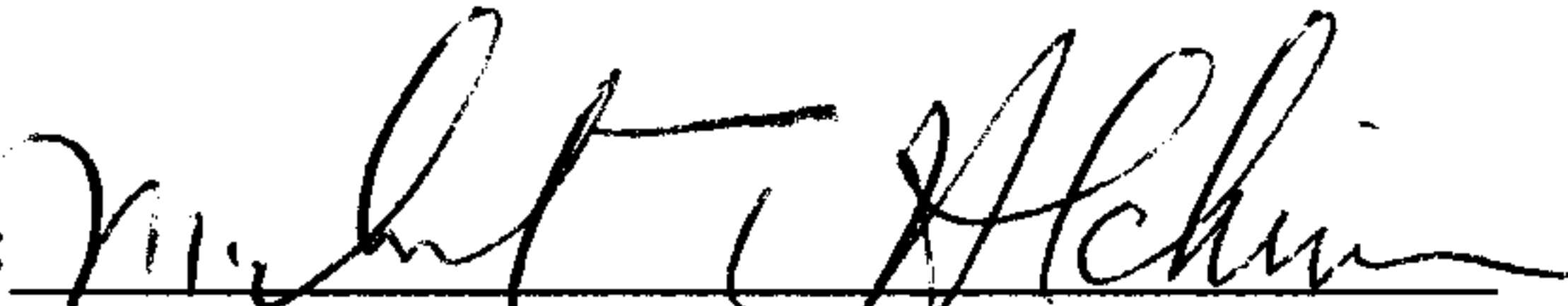

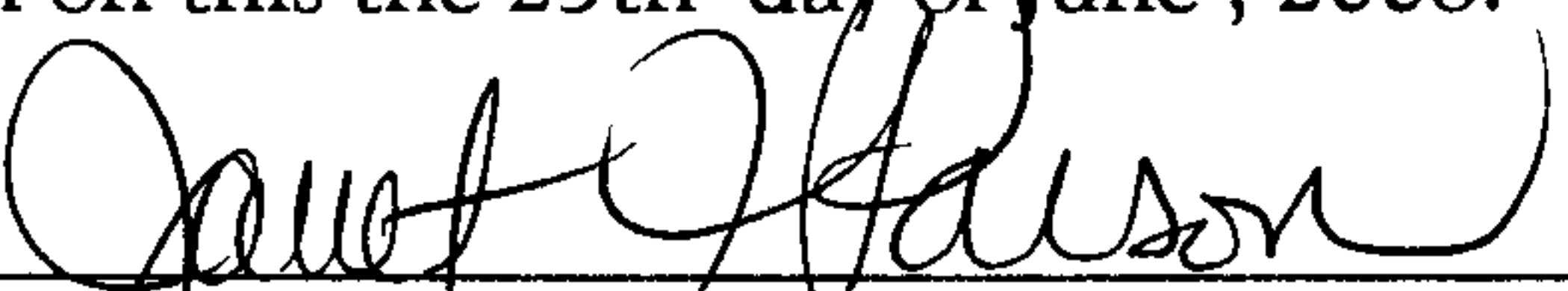
