KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of One Dollar (\$1.00) and other good and valuable consideration unto the undersigned **Bishop Robert J. Baker, Bishop of Birmingham in Alabama**, a corporation in sole (hereinafter at times referred to as the "Grantor"), in hand paid by **Alabama Gas Corporation**, an Alabama corporation, the receipt and sufficiency of which is hereby acknowledged, does hereby grant, bargain, sell and convey unto the said Alabama Gas Corporation, its successors, assigns and lessees from the date hereof a non-exclusive right-of-way and easement for any one or more of the following purposes: Laying, constructing, erecting, setting, installing, renewing, repairing, inspecting, replacing, maintaining, operating, removing, changing the size of, modifying and relocating one or more of its pipe or pipelines, mains, conduits and appliances and appurtenances (the "facilities") thereto over, under, upon and across a proposed Alagasco easement situated on the East ten feet of Lot 2C, St. Thomas Church Subdivision, as recorded in the Office of the Judge of Probate, Shelby County, Alabama, in Map Book 25, Page 6, lying adjacent to and west of the right-of-way line of Alabama Highway #119, being 10 feet in width and 791 feet in length, containing 0.18 acres, more or less.

Together with the right of ingress to and egress from said strip of land adjacent lands of the Grantor and all the rights and privileges necessary or convenient for the full enjoyment and use of said right-of-way and easement for the purposes above designated.

TO HAVE AND TO HOLD the said right-of-way and easement perpetually unto the said ALABAMA GAS CORPORATION, and its successors, assigns and lessees, provided, however, that the Grantor herein expressly reserves for itself and its successors and assigns the right to use and enjoy the premises above described in so far as such use and enjoyment by the Grantor, its successors and assigns shall not unreasonably interfere with the use of said easement and right-of-way by the said ALABAMA GAS CORPORATION, its successors, assigns and the lessees under the grant herein set forth, and provided further that the Grantor and its successors, assigns will place no permanent structures upon the said right-of-way and easement. The Grantor expressly covenants that it is the owner in fee of the real property herein conveyed and has a good right to execute this agreement and to grant said easement and right-of-way.

In the event that the Grantor desires to relocate the facilities to another location, ALABAMA GAS CORPORATION agrees to relocate such facilities provided that Grantor executes an easement providing ALABAMA GAS CORPORATION with identical rights as provided for herein. Any such relocation of the facilities shall be at the sole cost and expense of the Grantor.




