KNOW ALL MEN BY THESE PRESENTS, THAT

Whereas, on the 4th day of April, 2005 a decree was rendered by the Probate Court of said county for the sale of the lands, hereinafter described, and conveyed for the state and county taxes then due from **American Land Development Corporation**, the owners of said land for the costs and expenses thereof and thereunder.
