KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 25th day of May, 2006, Jason Kent O'Daniel and Sonya M. O'Daniel, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for CitiMortgage, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20060613000279380, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc., by instrument recorded in Inst. # 20080714000284140, in the aforesaid Probate Office ("Transferee"); and

County, Alabama.

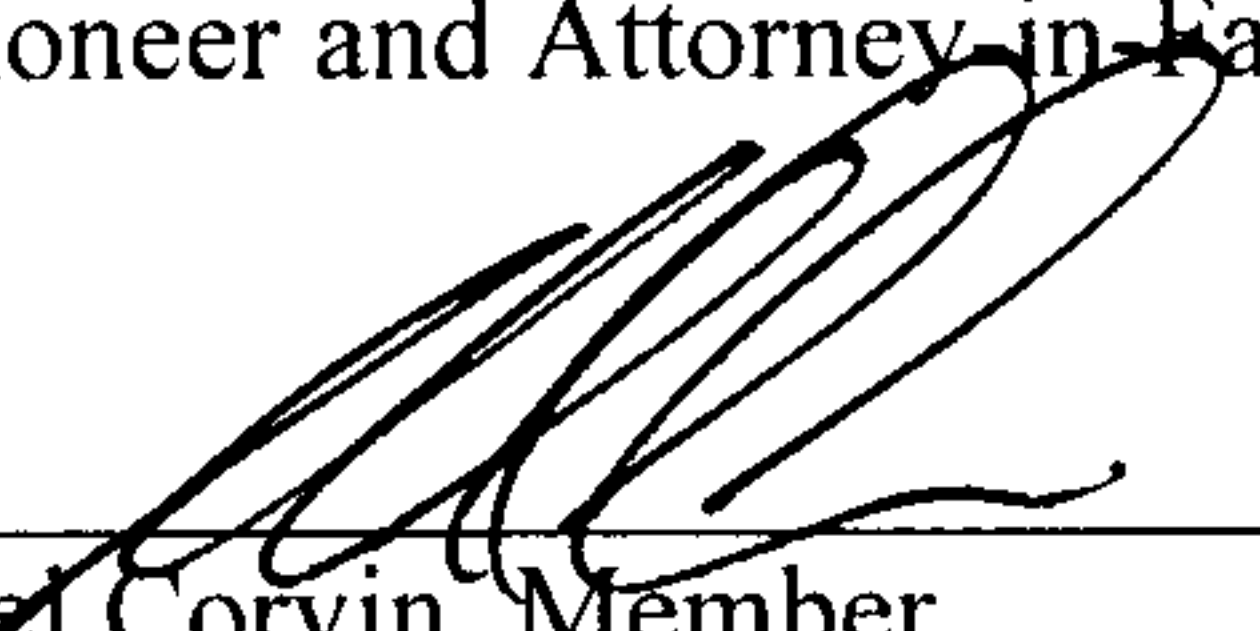

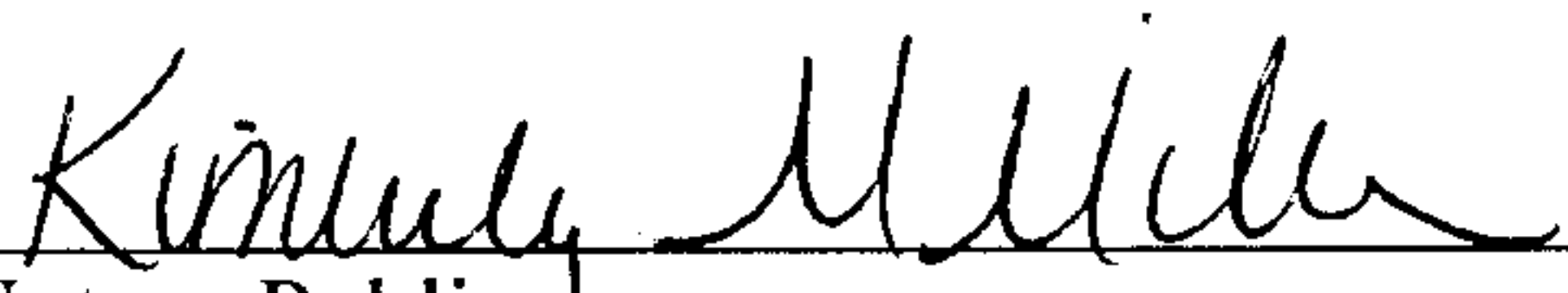
