KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Two Hundred Thousand and 00/100 (\$200,000.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS, **Steve Fournier and Heather Leigh Fournier, husband and wife** (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Clara A. Lorino and Kenneth A. Lorino, wife and husband**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

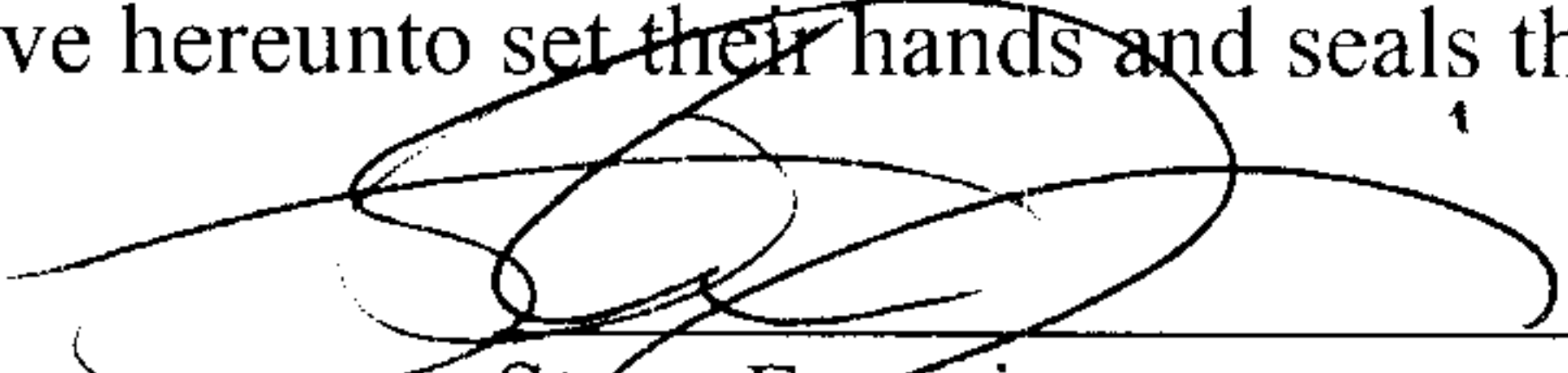
Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.

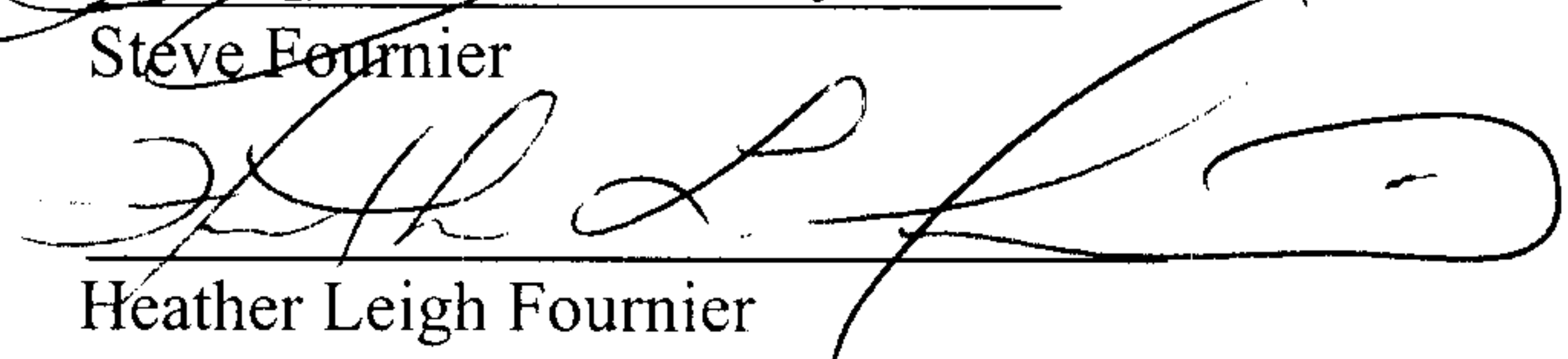
THIS DEED IS BEING RE-RECORDED TO CORRECT THE LOT NUMBERS IN THE LEGAL DESCRIPTION.

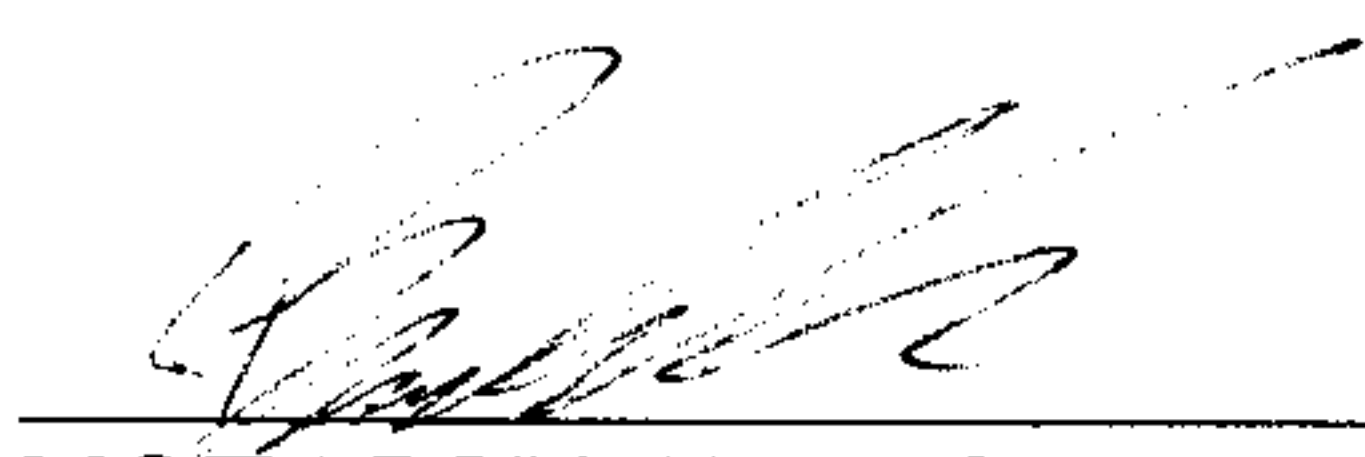

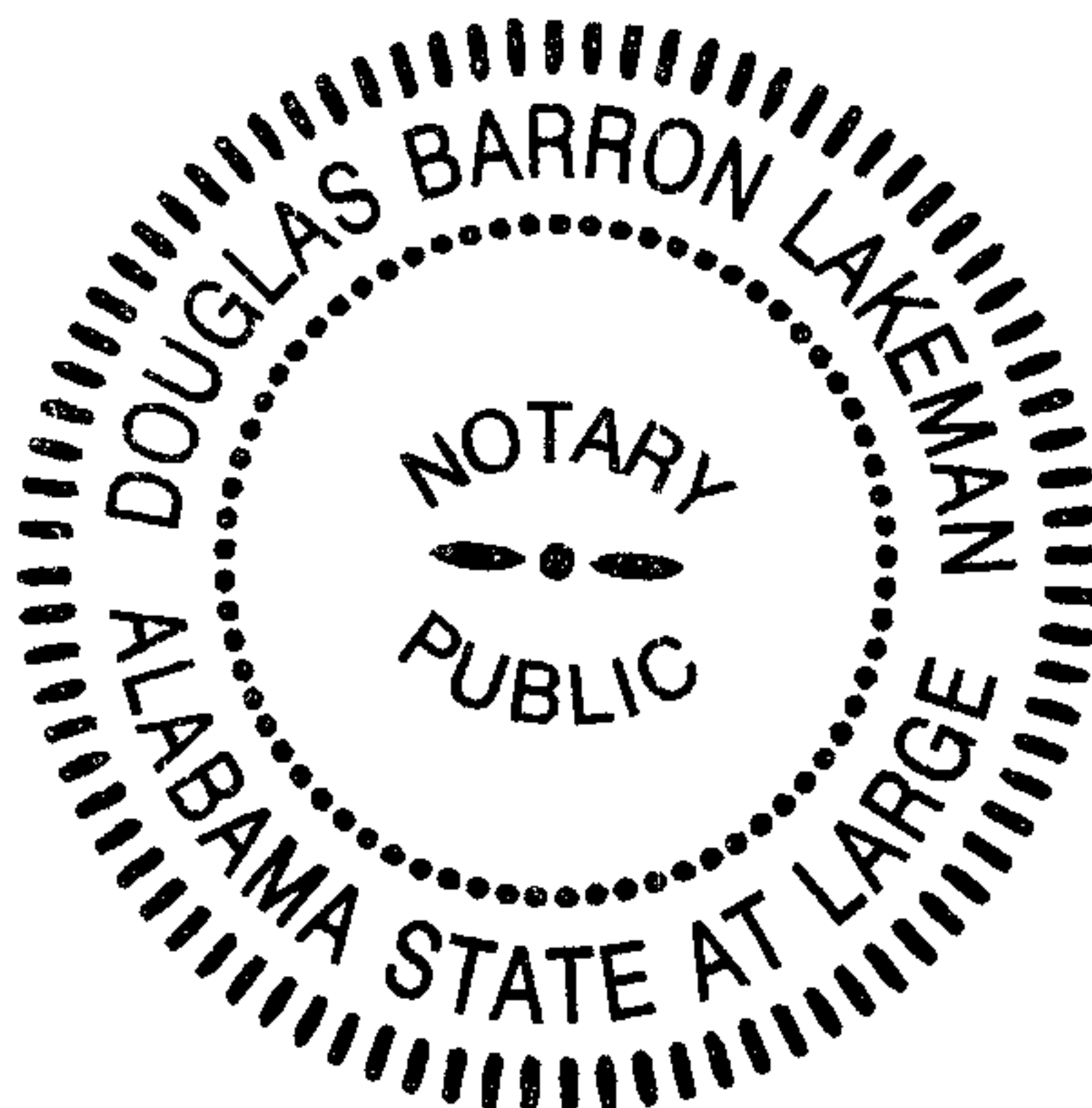

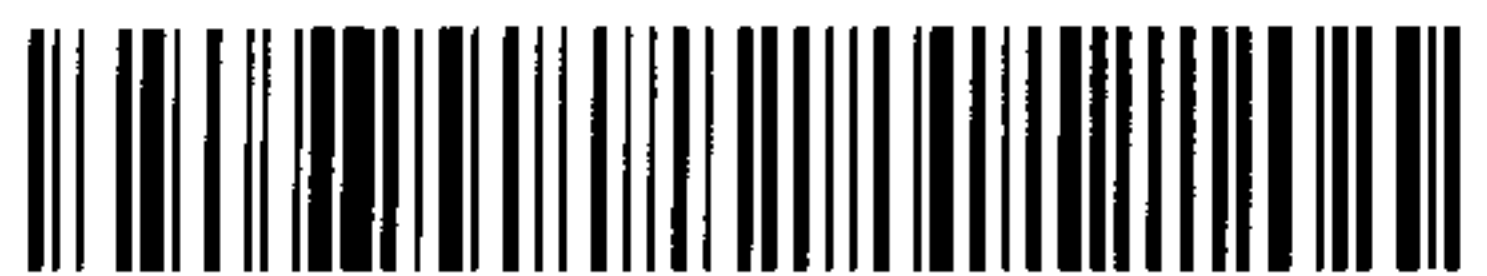
