(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Scott W. Boone and Leigh Ann Boone

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

Lot 122, according to the Amended Map of Hickory Ridge Subdivision, as recorded in Map Book 11, Page 79, in the Office of the Judge of Probate of Shelby County, Alabama

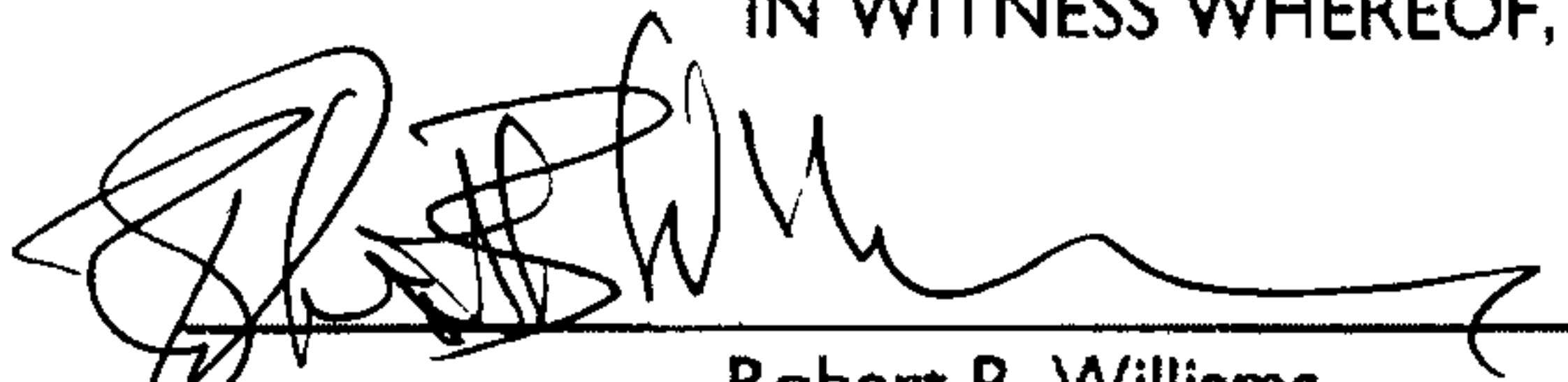
\$141,000.00 of the proceeds come from a mortgage recorded simultaneously herewith.

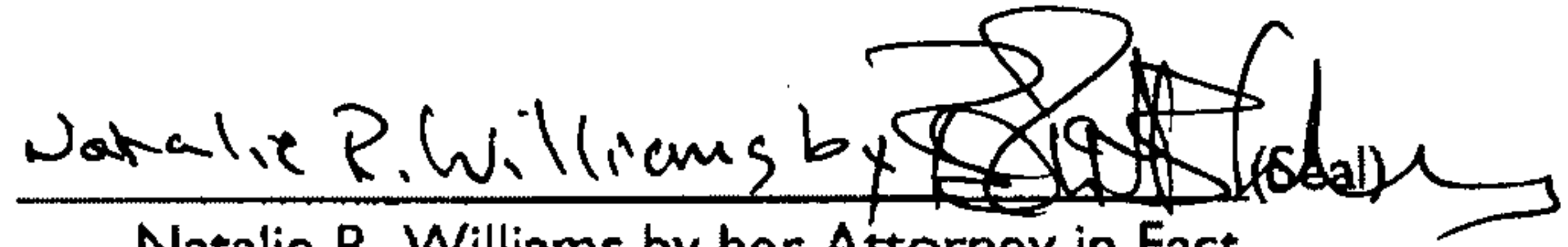
Subject to: (1) 2008 ad valorem taxes not yet due and payable;

TO HAVE AND TO HOLD unto Grantees as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And we do for ourselves and for our heirs, executors, and administrators covenant with Grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to Grantees, their heirs and assigns forever, against the lawful claims of all persons.

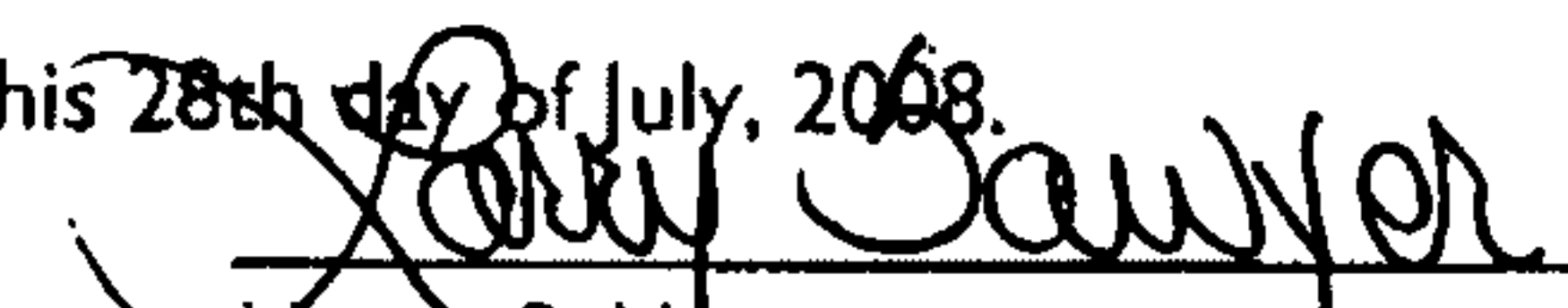
