(herein referred to as Grantor, whether one or more), grant, bargain, sell, and convey unto

**WILSON HAUCK AND ANNE S. HAUCK, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE HAUCK LIVING TRUST, DATED AUGUST 7, 2008 AND ANY AMENDMENTS THERETO**

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEE, his, her or their successors and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEE, his, her or their successors and assigns forever, against the lawful claims of all persons

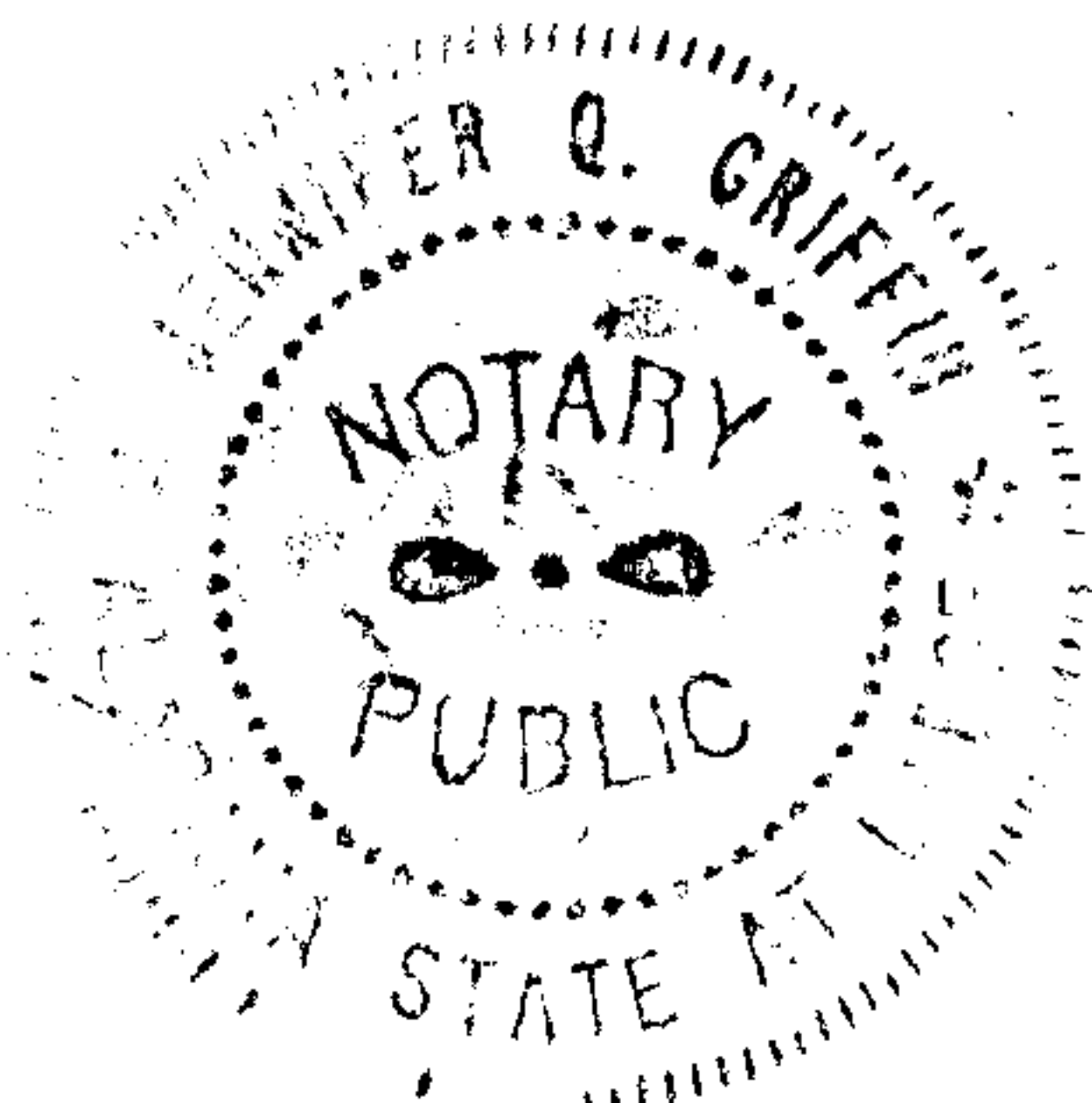
