FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 27th day of February, 2006, James M. Otts and Jennifer L. Otts , married, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. as nominee for First Franklin A Division of Nat. 3, Page 125, in the Office of the Judge of Probate of Shelby County, Alabama.

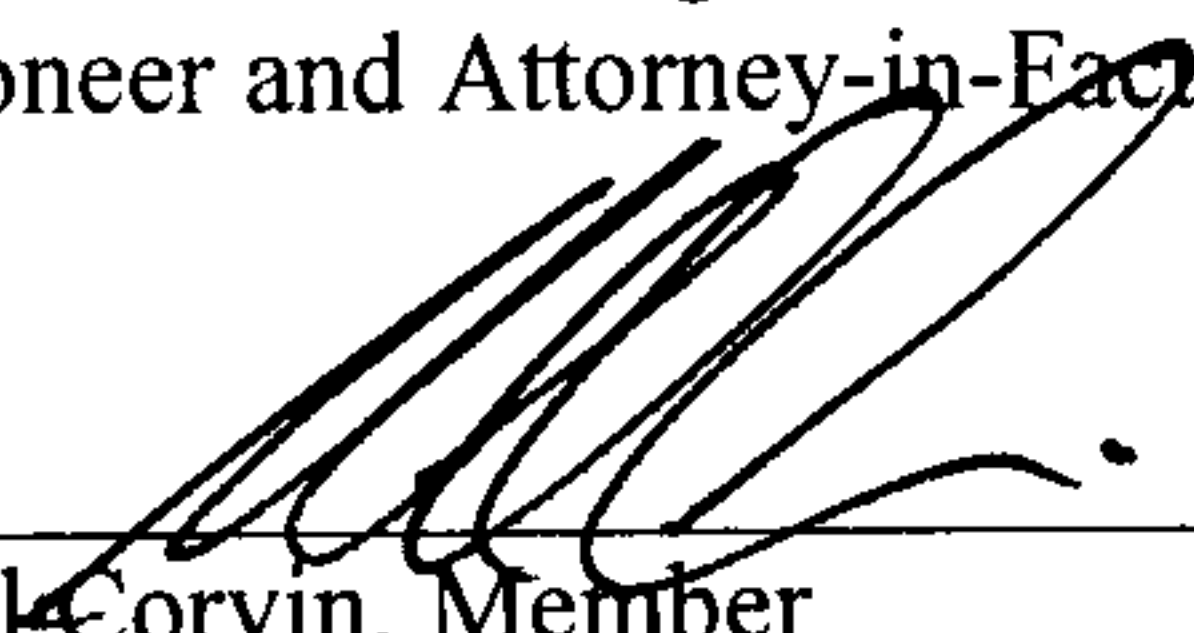

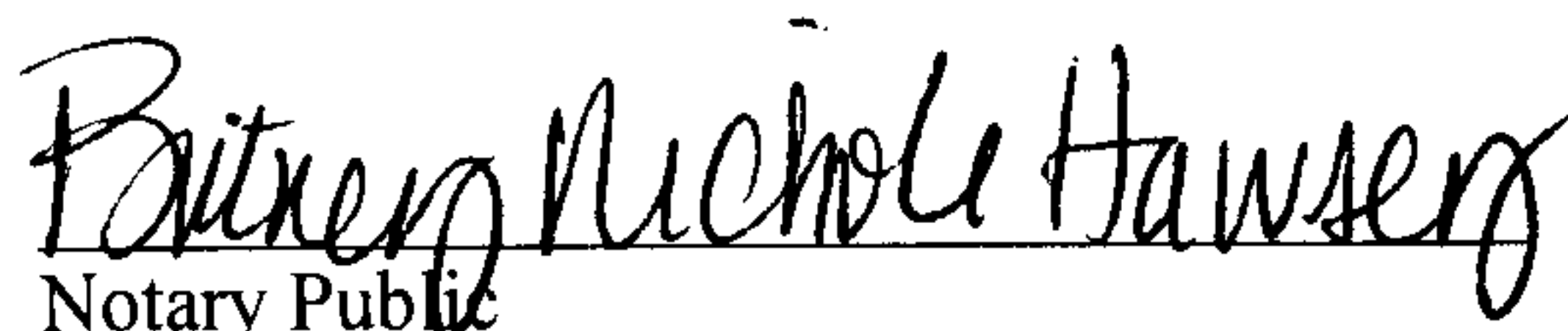
