Description of entire width (varies) road right-of-way for Cahaba Beach Road to be vacated; said road right-of-way believed to be 60 feet wide in Jefferson County, as per the tax map, and 50 feet wide in Shelby County, as per the tax map, and the centerline being described as follows:

Part of the W $\frac{1}{2}$ of the NE $\frac{1}{4}$ and part of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$, all in Section 25, Township 18 South, Range 2 West, Jefferson and Shelby Counties, Alabama, being more particularly described as follows:

From the NE corner of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Section 25, run in a southerly direction along the east line of said $\frac{1}{4}$ - $\frac{1}{4}$ section for a distance of 361.01 feet and to a point on the north line of the Susan Greene Pitts property; thence turn an angle to the left of 88°-08'-30" and run in an easterly direction for a distance of 55 feet to a point in the center of the Little Cahaba River; thence in a southeasterly direction along the center of the Little Cahaba River a distance of 390 feet, more or less, to a point on the south line of the Susan Greene Pitts property; thence in a westerly direction along a line parallel to the north line of said Section 25, said line being 368.57 feet south of, measured perpendicular from the north line of the Susan Greene Pitts parcel of land, a distance of 827.34 feet to a point on the northeasterly right-of-way line of an existing county road (Cahaba Beach Road) and being the southwest corner of the Susan Greene Pitts property; thence continue in a westerly direction along the last mentioned course for a distance of 31.3 feet to the center of Cahaba Beach Road; thence turn an angle to the left and run in a southeasterly direction along the center of Cahaba Beach Road for a distance of 10.0 feet to the point of beginning of the land to be vacated; thence continue in a southeasterly, southerly and southwesterly direction along the centerline of said Cahaba Beach Road for a distance of 600 feet, more or less, to the south line of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Section 25; thence continue in a southwesterly direction along the centerline of said Cahaba Beach Road for a distance of 500 feet, more or less, to a point where the road turns to the left in a southeasterly direction; thence run in a southeasterly and southerly and southeasterly direction along the centerline of said road for a distance of 1,800 feet, more or less, to a point of intersection with a line that is 10 feet west of the east line of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of said Section 25, being the point of ending of said road vacation.
