James R. Hollon, Jr. and James Ross Hollon are one and the same person.


Betty E. Hollon and Betty Espy Hollon are one and the same person.


\$120,000.00 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.


To Have and to Hold to the said grantee, his, her or their heirs and assigns forever.


