That said Association claims a lien upon property owned by **James G. and Paige E. Dyer** situated in Shelby County, Alabama described as follows:

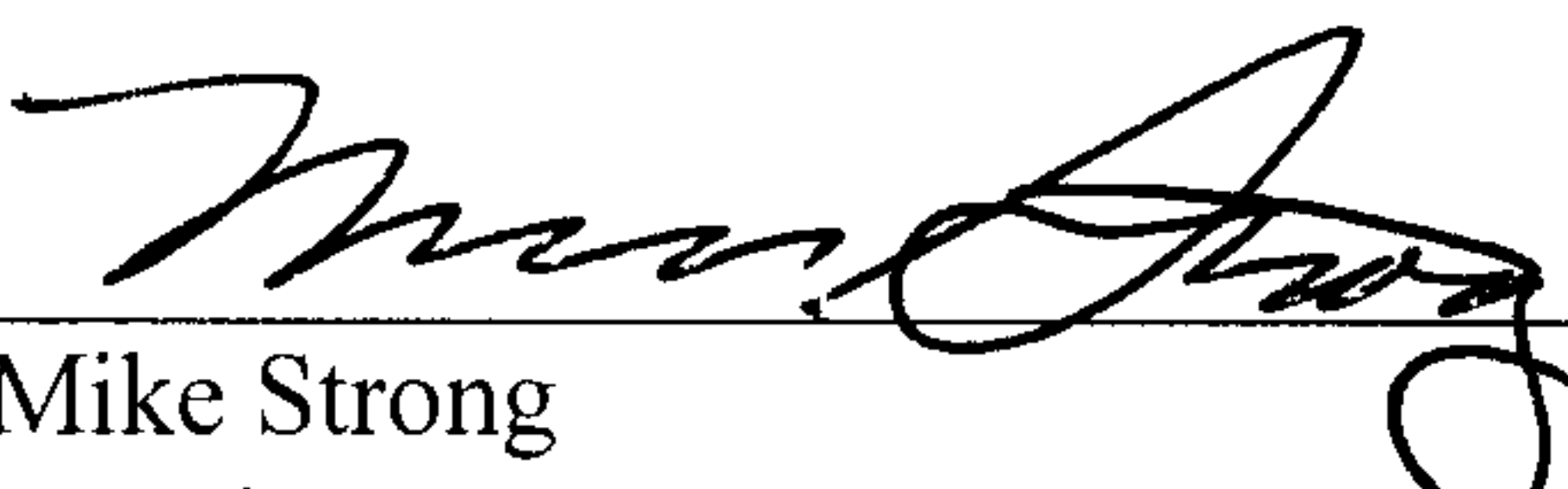

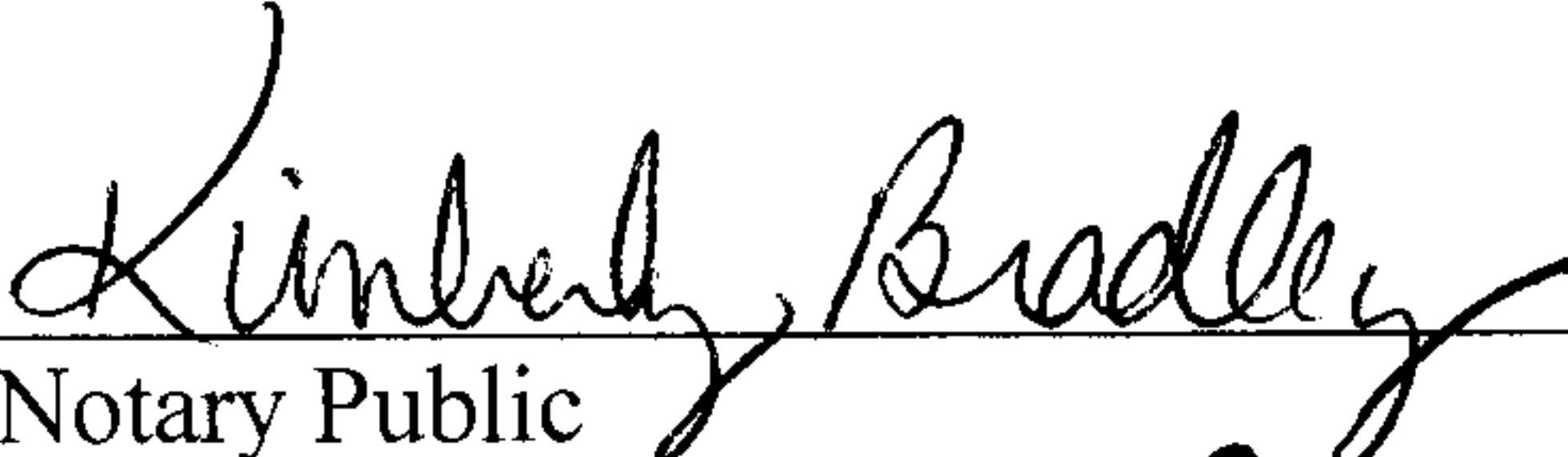
