\$162,616.00 was paid from first mortgage recorded herewith.





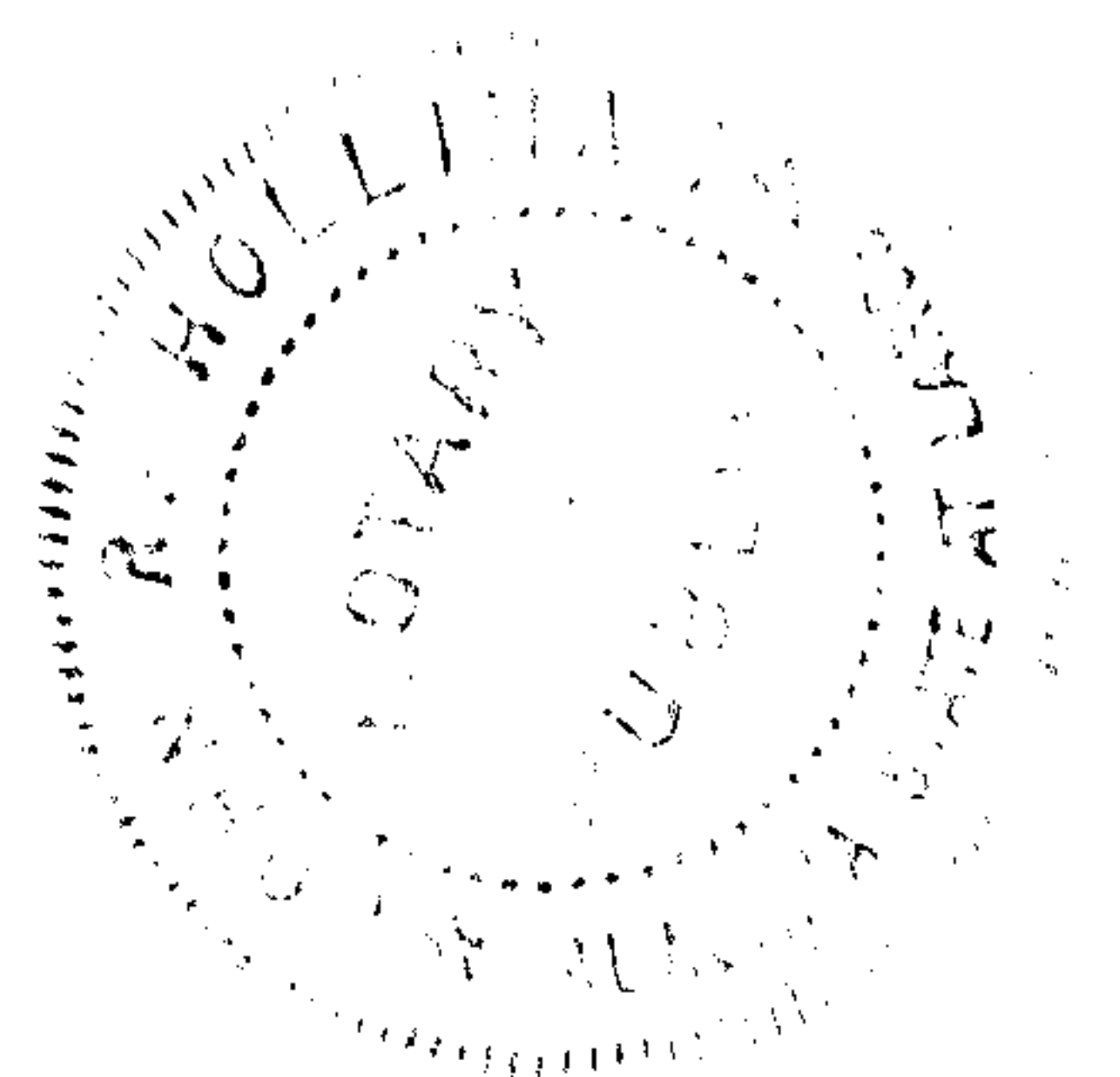
