That in consideration of **THREE HUNDRED SEVEN THOUSAND AND NO/100'S (\$307,000.00) DOLLARS** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, **PARMLEY BUILDER, INC.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **BEN A. SALINAS AND NANCY M. SALINAS** (herein referred to as GRANTEES, whether one or more), as joint tenants with right of survivorship, the following described real estate, situated in **JEFFERSON County, Alabama to-wit:**

LOT 502, ACCORDING TO THE FINAL PLAT OF TIMBERLAKE SECTOR 5, AS RECORDED IN MAP BOOK 36, PAGE 11, IN THE PROBATE OFFICE OF SHELBY COUNTY, ALABAMA AND RECORDED IN MAP BOOK 41, PAGE 47 IN THE BESSEMER DIVISION OF THE PROBATE OFFICE OF JEFFERSON COUNTY, ALABAMA.

This conveyance is made subject to covenants, restrictions, reservations, easements and rights-of-ways, if any, heretofore imposed of record affecting Grantor's title to said property, and municipal zoning ordinances now or hereafter becoming applicable and taxes or assessments now or hereafter becoming due against said property.

\$245,595.00 of the consideration herein was derived from a mortgage loan closed simultaneously herewith.



The preparer of this instrument has served as a scrivener only and has not examined title to the property for purposes of Grantors's representations made herein or rendered any opinion with respect thereto.

And I (we) do, for myself (ourselves) and for my (our) heirs, executors and administrators, covenant with said GRANTEES, his, her or their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise stated above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will, and my (our) heirs, executors and administrators shall warrant and defend the same to the said grantee, his, her or their heirs and assigns forever, against the lawful claims of all persons.


