TOWNSHIP 20 SOUTH, RANGE 1 WEST, SHELBY COUNTY, ALABAMA:

Section 29:

The East one-half of the Northwest ¼; the Southwest ¼ of the Northwest ¼; the North one-half of the Southwest ¼; the Southwest ¼ of the Southwest ¼.

Section 30:

The South one-half of the Southwest ¼; the East one-half of the Southeast ¼; the Southwest ¼ of the Southeast ¼.

Section 31:

The Northwest 1/4 of the Northeast 1/4 and the Northeast 1/4 of the Northwest 1/4.

TOWNSHIP 20 SOUTH, RANGE 2 WEST, SHELBY COUNTY, ALABAMA:

Section 23:

The Southeast 1/4 of the Northeast 1/4.

Section 24:

That part of the Southeast ¼ of the Southwest ¼ lying South of Fire Tower Road; the West one-half of the Southeast ¼ lying South of Fire Tower Road.

Section 25:
