MORTGAGE MODIFICATION AGREEMENT

THIS MORTGAGE MODIFICATION AGREEMENT is made and entered into on June 12, 2008 by and between Calera and Shelby Railroad and Museum, Inc, DBA Heart of Dixie Railroad Museum, Inc (hereinafter referred to as the "Mortgagor") and CENTRAL STATE BANK, (hereinafter called the "Mortgagee").

Mortgagor has entered into an original mortgage agreement with Mortgagee on 09/05/2003 as recorded in Inst# 20030918000629440 on 09/18/2003 and rerecorded in Inst# 20040220000089540 on 02/20/2004 to correct name, and reinstated on 05/28/2008 and recorded in Inst# 20080606000230130 in the Office of the Judge of Probate of Shelby County, Alabama. Both Mortgagor and Mortgagee desire to amend the terms of the original mortgage and note executed simultaneously therewith.

These things considered, Mortgagee hereby allows Mortgagor to increase the original mortgage from Eight Seven Thousand One Hundred Seventy Nine Dollars and 80/100 (\$87,179.80) to One Hundred Twelve Thousand Dollars and 00/100 (\$112,000.00). The new note shall be secured by the original above described mortgage as amended herein and amortized under the terms and conditions of the new note executed simultaneously with this agreement.


