DEED – OIL, GAS AND MINERAL RIGHTS ONLY

WHEREAS, Sarah Fancher Strong is deceased, whose Last Will and Testament and Codicil was recorded on July 16, 1952 in Book 151, Page 137, Probate Court records of Shelby County, Alabama.

NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of Ten Dollars and other good and valuable consideration to the undersigned GRANTOR in hand paid by the GRANTEE herein, the receipt of which is acknowledged, Regions Bank (successor in interest through merger and acquisition of AmSouth Bank and The First National Bank of Mobile) as Trustee Under Item II (b) of the Last Will and Testament of Sarah Fancher Strong FBO of Jane Fancher Reich (the "Grantor"), does (subject to the exceptions and limitations hereinafter contained) hereby assign, transfer, distribute and convey an undivided one-third of one-fifth (1/3rd of 1/5th) interest in and to the oil, gas, and other minerals (of any kind) in, on, and under the real property located in Shelby County, Alabama and described on Exhibit A (the "Property") to Jane (AKA Jayne) Fancher Reich (the "Grantee").

In the event the estate of Sarah Fancher Strong owned more or less than an undivided one-fifth (1/5th) interest, then this distribution is increased or reduced proportionately; it being the intention of the Grantor to convey to the Grantee an undivided one-third interest in whatever fractional interest Sarah Fancher Strong may have owned in the oil, gas and minerals described on Exhibit "A", including any other property located in said county at the time of her death.

TO HAVE AND TO HOLD unto the Grantee, her successors and assigns, forever; subject to all oil, gas and/or other minerals and all rights in connection therewith, if any, as previously reserved by, or conveyed to, others; together with all and singular the rights and appurtenances thereto in any wise belonging, with the right of ingress and egress, and possession at all times for the purpose of mining, drilling, and operating for said minerals and the maintenance of facilities and means necessary or convenient for producing, treating, and transporting such minerals.

This conveyance is made subject to all matters of public record, prior reservations, exceptions and any valid and subsisting oil, gas or other mineral leases, pooling agreements, and unitization agreements. This conveyance is made without warranty of title either express or implied.
