STATUTORY WARRANTY DEED

Know All Men by These Presents: That in consideration of **ONE HUNDRED FORTY ONE THOUSAND NINE HUNDRED AND NO/100 DOLLARS (\$141,900.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt of which is acknowledged, I or we, **THE LORRIN GROUP, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **SAMANTHA J. ARMISTEAD** (herein referred to as grantees, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 125, according to the Survey of The Villages at Westover Sector 1, as recorded in Map Book 39, page 9 A & B, in the Probate Office of Shelby County, Alabama.

Subject to:

Grantees acknowledge that they have made their own independent inspections and investigations of the subject property and are purchasing the subject property in reliance upon such inspections and investigations. For purposes of this paragraph, Grantor shall mean and refer to the members, managers, agents, employees, successors, assigns, members, owners, managers, partners, officers and contractors of Grantor and any successors and assigns of Grantor.

The grantor covenants and agrees that the grantor is executing this Deed in accordance with the Articles of Organization and Operating Agreement of The Lorrin Group, LLC, which have not been modified or amended.

To Have And To Hold to the said grantees, his, her or their heirs and assigns forever.


