KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of **One Hundred Ninety Two Thousand Five Hundred dollars and Zero cents ( \$192,500.00 )** paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **Bart Batson and Lauren Batson** (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **John Gabriel Fuller and Lee Ann Fuller as joint tenants with rights of survivorship** (hereinafter Grantees), all of my/our right, title and interest in the following described real es tate, situated in **Shelby County, Alabama**:
