Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.


**This warranty deed is executed as required by the Articles of Organization and Operating Agreement and the same Articles of Organization and Operating Agreement have not been modified or amended.**

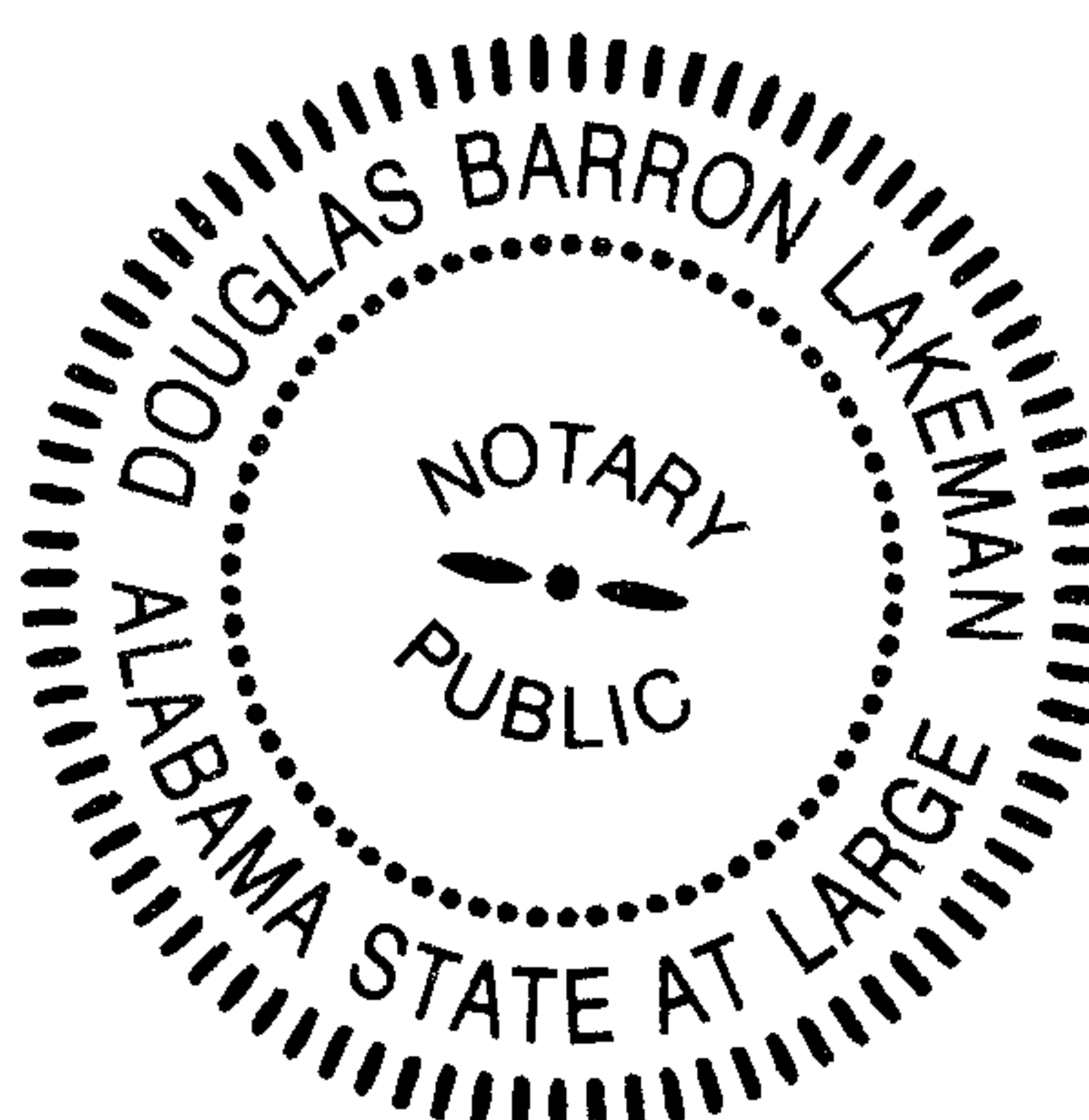
