KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of April, 2007, Cynthia M. Howell and Michael L. Howell Sr., wife and husband, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for DHI Mortgage Company LTD, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070503000206800, said mortgage having subsequently been transferred and assigned to Countrywide Home Loans, Inc. 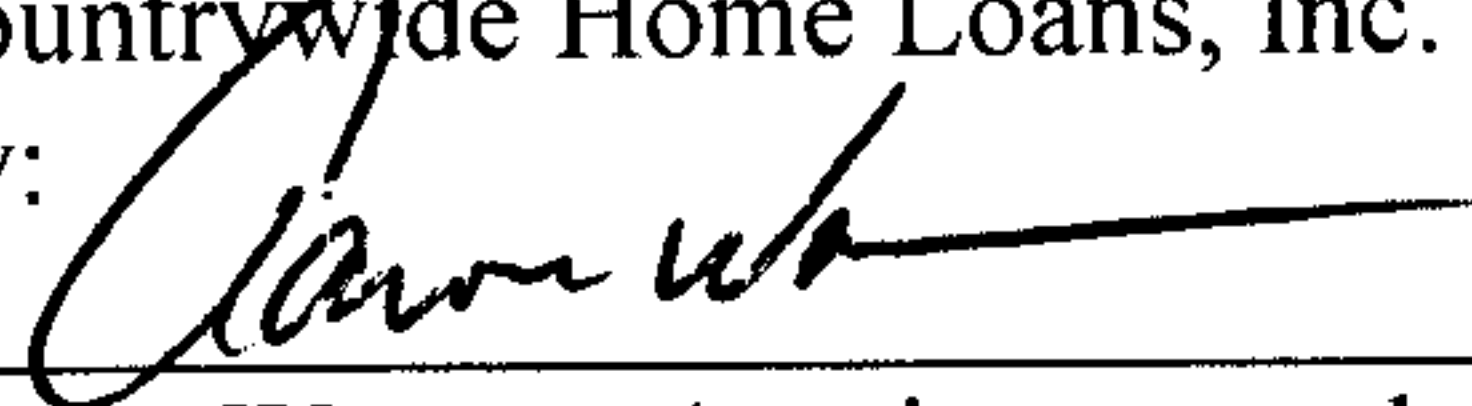

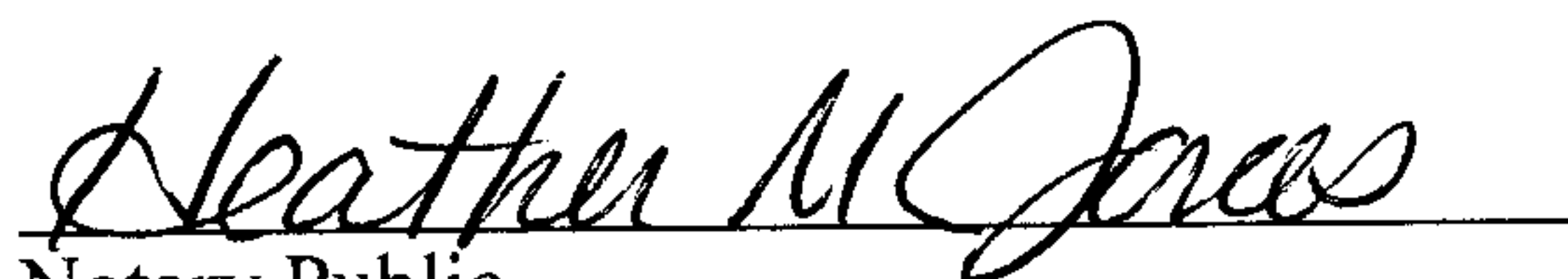

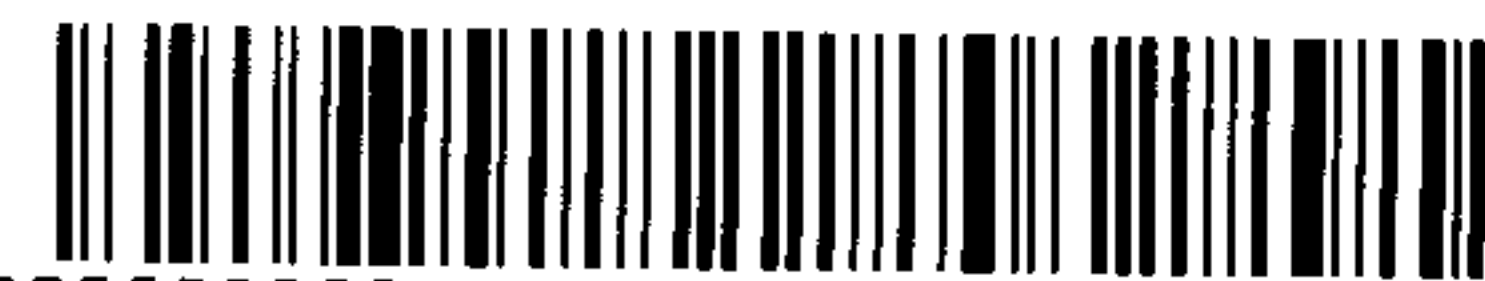
