KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 15th day of June, 2007, Joseph Dowdell, an unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. is acting solely as a nominee for Countrywide Home Loans, Inc. 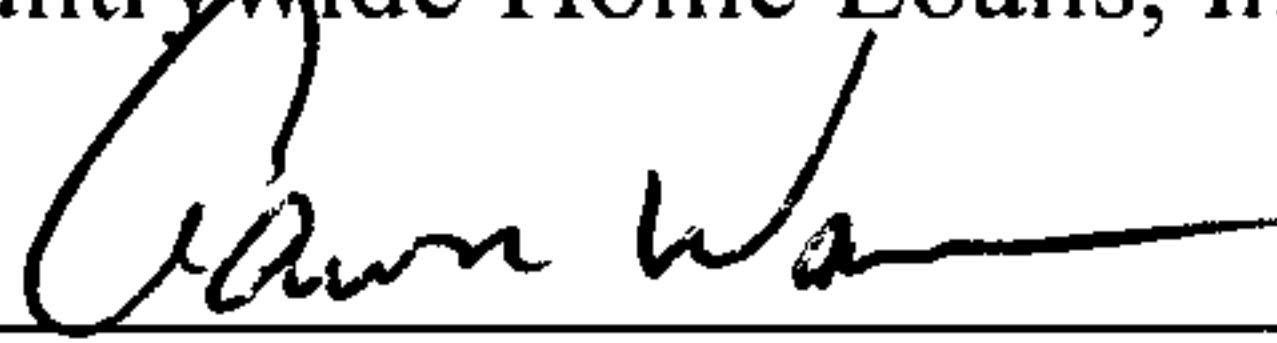

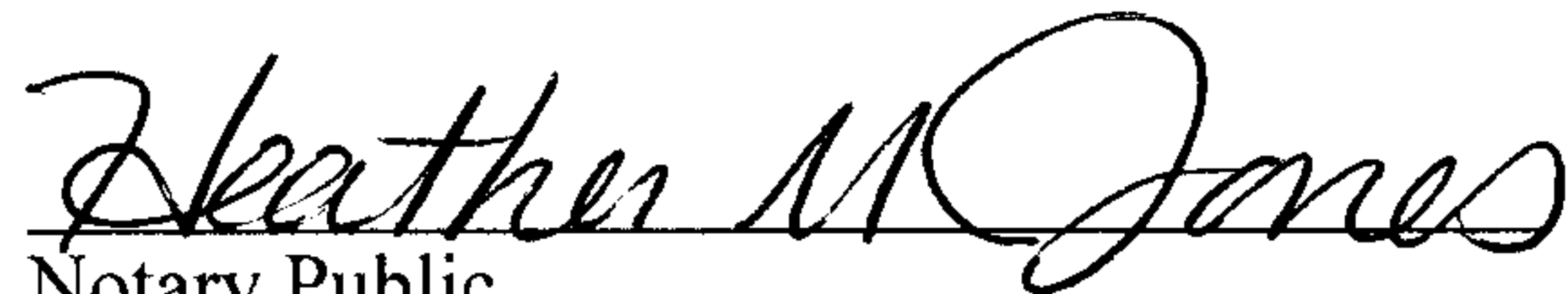
