Before me, the undersigned authority, in and for said County and State, personally appeared Martin Dates, who, being known to me and being by me first duly sworn, deposed and said as follows:

My name is Martin Dates. I am 64 years old and reside in Shelby County, Alabama. I knew Nettie J. Kidd, deceased, and am acquainted with her family. Nettie J. Kidd died on December 2, 1986, without a will, and no administration of her estate is pending or contemplated, and no one is appointed as executor, administrator, or personal representative of the deceased. There are no claims against her or her estate as far as I know and no lawsuits pending or threatened against her or her estate.

Nettie J. Kidd never married and had no children. She lived on the following described property which is located in Vincent, Shelby County, Alabama:

SW $\frac{1}{4}$  of NW $\frac{1}{4}$  of Section 1, Township 19 South, Range 2 East

All of that part of the SE $\frac{1}{4}$  of NE $\frac{1}{4}$  of Section 2, Township 19 South, Range 2 East, lying east of the Coosa Valley Road, less the part deeded to the church.

NE $\frac{1}{4}$  of SW $\frac{1}{4}$  and N $\frac{1}{2}$  of SE $\frac{1}{4}$  of SW $\frac{1}{4}$ , except 2 acres off NW corner of said NE $\frac{1}{4}$  of SW $\frac{1}{4}$ , in Section 1, Township 19 South, Range 2 East.

I have been informed that this property was owned by her father, Mack Kidd, who obtained it by deeds recorded in Deed Book 35, page 82, and Deed Book 36, page 441, in the Probate Office of Shelby County, Alabama. Mack Kidd died in the early 1940's.

When Nettie J. Kidd died, she left surviving as next of kin and sole heirs at law the descendants of Mack Kidd, who were her brothers and sisters or the children of her deceased brothers and sisters. The following are all of the children of Mack Kidd:

1. **Robert Kidd**, died before Nettie J. Kidd, whose children are Robert E. Kidd, Wallace Kidd (died before Nettie J. Kidd with no children or spouse), George Kidd (died before Nettie J. Kidd with no children or spouse), Trunetta Robinson, and Mae Robert Kidd

2. **Stanley Kidd**, died before Nettie J. Kidd, whose only child is Alzie Davis

3. **Charlie Kidd**, died after Nettie J. Kidd, leaving a surviving spouse, Maple Fair, who has since died leaving an unknown number of children

4. **Ada Datcher**, died before Nettie J. Kidd, whose children are Lester Datcher and Yancey Datcher (died, leaving the following known children, Ann Datcher, Margareta Datcher, and Douglas Datcher)

5. **Annie Stockdale**, died after Nettie J. Kidd, and whose spouse is deceased, whose children are Joe Stockdale (died, unknown children), Catherine Stockdale (died, unknown children, one believed to be Evelyn), Louse Stockdale, Mary Stockdale, Barbara Stockdale, and Mack Stockdale

Robert E. Kidd, Nettie J. Kidd's nephew and one of the children of her deceased brother, Robert Kidd, has been looking after the property and paying the property taxes following Nettie J. Kidd's death.
