THIS FORECLOSURE DEED made this 9th day of September, 2008, between RUSSELL L. CARTER and KIMBERLY M. CARTER, husband and wife, Parties of the First Part, and HOME SALES, INC. OF DELAWARE, Party of the Second Part;

W I T N E S S E T H:

WHEREAS, the said RUSSELL L. CARTER and KIMBERLY M.
