

WARRANTY DEED

STATE OF ALABAMA
SHELBY COUNTY

KNOW ALL MEN BY THESE PRESENTS, that in consideration of One and 00/100 Dollar and other valuable consideration to the Grantor in hand paid by the Grantee herein, the receipt whereof is hereby acknowledged, **First Lowndes Bank, an Alabama corporation** (herein referred to as Grantor), does hereby GRANT, BARGAIN, SELL and CONVEY unto **Reginald Bernard Green and Lavonda K. Green** (herein referred to as Grantee), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, situated in the County of Shelby, and State of Alabama, to-wit:

Lot 65, according to the Final Plat of Nottingham, Phase 2, as recorded in Map Book 31, Page 62 in the Probate Office of Shelby County, Alabama being situated in Shelby County, Alabama.

This conveyance is made subject to any easements, restrictions, reservations, easements and right-of-way, if any, heretofore imposed of record affecting title to said property, municipal zoning ordinances, and taxes or assessments now or hereafter becoming due against said property and/or covenants appearing of record affecting said property,

This deed is subject to the rights of redemption from foreclosure.

TO HAVE AND TO HOLD to the said Grantees, for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to their heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

And Grantors do covenant with the said Grantees, their heirs and assigns, that they are lawfully seized in fee simple of the aforementioned premises, that it is free from all encumbrances, except as hereinabove provided; that they have a good right to sell and convey the same to the said Grantees, their heirs and assigns, and that Grantors will warrant and defend the premises to the said Grantees, their heirs and assigns forever, against the lawful claims and demands of all persons, except as hereinabove provided.

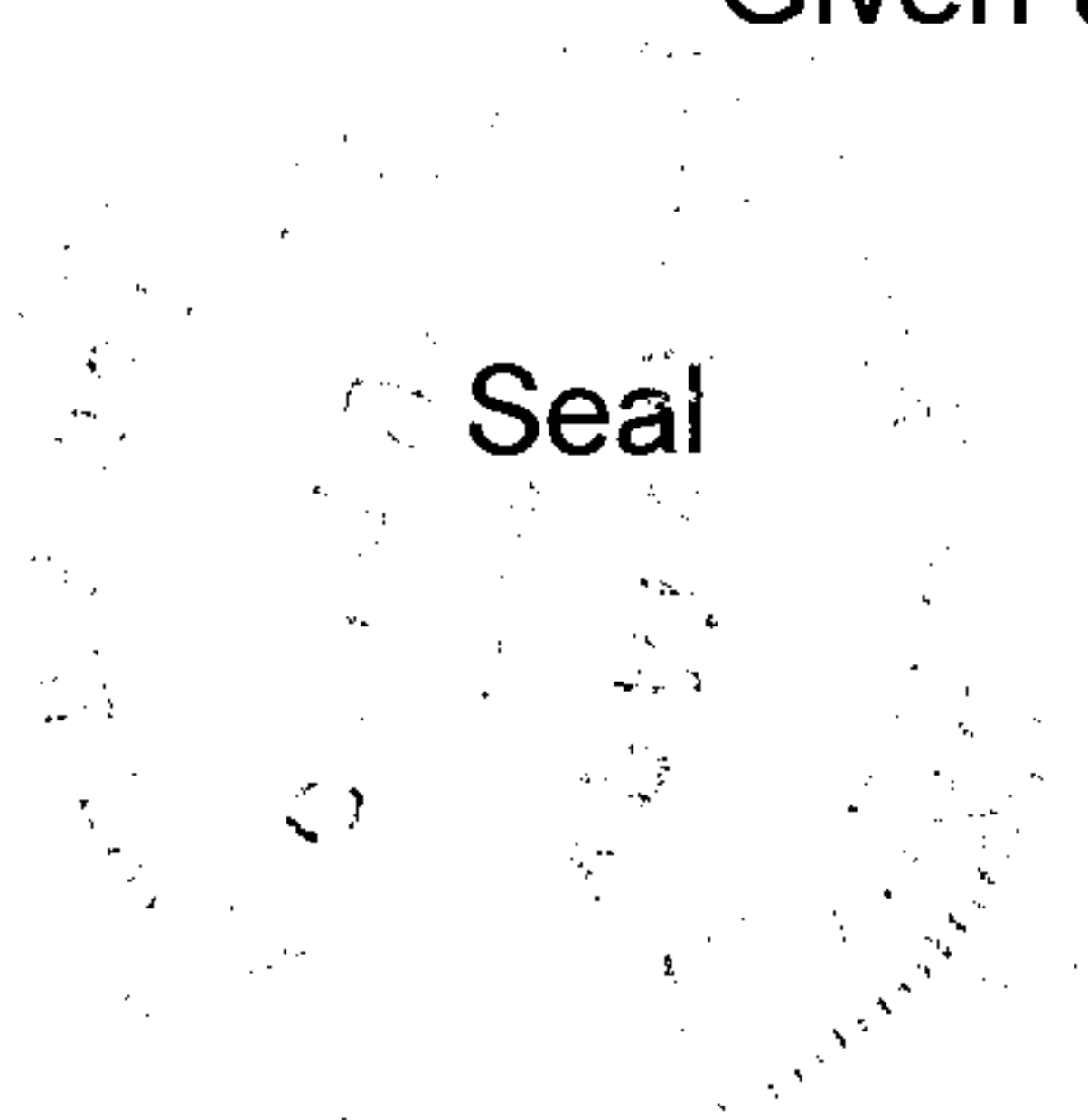


