Riddle, deceased, (herein referred to as Grantor) does grant, bargain, sell and convey unto Marilyn Ann Riddle Cooke, (herein referred to as Grantee), all of said decedent's rights, title, interests and claims to the following described real estate situated in Shelby County, Alabama, to wit:

Parcel I:
