THIS AGREEMENT is made and entered into on thisday of
, 2008, by Wachovia Bank, N.A. (herein after referred to as "Wachovia Bank, N.A.") in favor of HOMETOWN MORTGAGE SERVICES, INC., its successors and assigns (hereinafter referred to as the "Lender").
RECITALS
Wachovia Bank, N.A. loaned to Jamie K. Harding (the "Borrower", whether one or more) the sum of \$43,500.00. Such loan is evidenced by a note dated September 7, 2006, executed by Borrower(s) in favor of Wachovia Bank, N.A., which note is secured by a mortgage, deed of trust, security deed to secure debt, or other security agreement recorded October 4, 2006, in Instrument Number 20061004000492430, in the Office of the Judge of Probate of Shelby County Alabama. In consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of all of which is hereby acknowledged, Wachovia Bank, N.A. agrees that the Mortgage shall be and remain at all times a lien or charge on the property covered by the Mortgage prior and superior to the lien or charge of Wachovia Bank, N.A. in the extent the Mortgage secures the debt evidenced by the Note and any and all renewals and extensions thereof, or of any part thereof, and all interest payable on all of said debt and on any and all such renewals and extensions, and to the extent of advances made under the Note or the Mortgage necessary to preserve the rights or interest of Lender thereunder, but not to the extent of any other future advances. Wachovia Bank, N.A. hereby agrees to subordinate its note, mortgage and lien to HomeTown Mortgage Services, Inc., its successors and/or assigns.
