PARTIAL TERMINATION OF DEVELOPMENT AGREEMENT

THIS PARTIAL TERMINATION OF DEVELOPMENT AGREEMENT (this "Partial Termination") is made and entered into as of the Zalday of Supt., 2008 by and between EBSCO DEVELOPMENT COMPANY, INC., an Alabama corporation ("Seller"), and HILLTOP MONTESSORI SCHOOL, INC., an Alabama nonprofit corporation ("Purchaser").

RECITALS:

Seller and Purchaser have heretofore entered into a Development Agreement dated as of January 4, 2006 (the "Agreement") which has been recorded as Instrument No. 20060105000007310 in the Office of the Judge of Probate of Shelby County, Alabama. Capitalized terms not otherwise expressly defined herein shall have the same meanings given to them in the Agreement.

Pursuant to Paragraph 6 of the Agreement, the parties desire to acknowledge and agree that (a) the Final Subdivision Plat has been approved by the County and recorded in the Probate Office, (b) the conveyances and releases required pursuant to <u>Paragraphs 3(d)</u>, <u>4(b)</u> and <u>4(c)</u> of the Agreement have occurred and (c) subject to the terms and provisions of said <u>Paragraph 6</u> of the Agreement, the Agreement will be partially terminated.


NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Seller and Purchaser do hereby acknowledge and agree that, except for the indemnification obligations of Purchaser set forth in <u>Paragraphs 4(h)</u>, <u>4(i)</u> and <u>5</u> of the Agreement, the Agreement is hereby terminated, is deemed null and void and shall be of no further force or effect.




- 1. Consent to and approve of the execution of the Partial Termination by Seller and Purchaser.
