**KNOW ALL MEN BY THESE PRESENTS**, That in consideration of the sum of **Two Hundred Fifty Four Thousand dollars and Zero cents ( \$254,000.00 )** paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **David Swan and Gay Lynn Swan, husband and wife**, (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **Conley Lovette and Kristi Lovette as joint tenants with rights of survivorship** (hereinafter Grantees), all of my/our right, title and interest in the following described real estate, situated in **Shelby County, Alabama**:


Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.


