KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of April, 2005, James B. Bishop and Joy A. Bishop, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Professionals, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20050506000217500, said mortgage having subsequently been transferred and assigned to Countrywide Document Custody Services, a division of Treasury Bank, N.A., successor by merger to Countrywide Home Loans, Inc., by instrument recorded in Instrument Number 20060628000311760, in the aforesaid Probate Office ("Transferee"); and


